**2. The Details of the invited tender are as follows:**

**3. The Tender has been floated on e-proc2 Portal for total 07 (Seven) Medical Devices/Consumables.**

9. According to the comparative chart above, a total of six (06) bidders, namely M/s Avantor Performance Materials India Private Limited, M/s Biogenix Inc. Pvt. Ltd., M/s Medsource Ozone Biomedicals Pvt. Ltd., M/s Meril Diagnostics Private Limited, M/s Oscar Medicare Pvt. Ltd., M/s SD Biosensor Healthcare Pvt. Ltd. were found technically qualified notwithstanding their product wise qualification status as mentioned above.

10. A total of four (04) bidders, namely M/s Alpine Biomedicals Private Limited, M/s Avecon Healthcare Pvt. Ltd., M/s Q-Line Biotech Private Limited & M/s Transasia Bio-Medicals Ltd. were found technically disqualified.

**11.** The manufacturing unit of total five (05) technically qualified firms, namely M/s Avantor Performance Materials India Private Limited, M/s Medsource Ozone Biomedicals Pvt. Ltd., M/s Meril Diagnostics Private Limited, M/s Oscar Medicare Pvt. Ltd. & M/s SD Biosensor Healthcare Pvt. Ltd. were inspected during last three years and/or has valid rate contract with BMSICL.

**12.** The manufacturing unit of the one (01) firm i.e., M/s Biogenix Inc. Pvt. Ltd. was not inspected during last three years and not has valid Rate Contract with BMSICL.

**13.** It was therefore recommended to inspect the manufacturing unit of the One (01) firm i.e., M/s Biogenix Inc. Pvt. Ltd.
