## 3. The Tender has been floated on e-proc2 Portal for the Drug Anti Diptheria Serum (ADS)/ Diptheria Anti Toxin 10000 IU Injection 10 ml.

**4.** Total two (02) bidders were found to have successfully submitted their bids on the e-proc2 online system. The submission status of original hard copy of Earnest Money Deposit (EMD), till the stipulated time was found as following: -

- 7. The Preliminary Evaluation of technical bids from the aforementioned bidding firms was conducted by the assigned team, including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the BMSICL website, and claims/objections were invited online vide notice no. 5889 dated 04/10/2024 on e-proc2.
- **8.** After evaluating the clarifications received from the bidders in response to the notice and close examination of the documents submitted by the firms, the Drug wise technical evaluation findings for each firm were recorded by TEC in its meeting dated 30.10.2024 with the help of Drugs Inspectors deputed at BMSICL as follows:
