8. The Preliminary Evaluation of technical bids from the aforementioned bidding firms was conducted by the assigned team, including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the BMSICL website, and claims/objections were invited online vide notice no. 6615 dated 22/10/2024 on e-proc2.

9. After evaluating the clarifications received from the bidders in response to the notice and close examination of the documents submitted by the firms, the Drug wise technical evaluation findings for each firm were recorded in today's meeting with the help of Drugs Inspectors deputed at BMSICL as follows:
