

Minutes of Technical Evaluation Committee Meeting for Evaluation of Demonstration Sheet for Tender No. BMSICL/2024-25/ME-348 held on 08th October 2024 at Conference hall of BMSICL Patna.

1. Attendance- As per the attendance register.
2. In the TEC meeting held on 09.08.2024, the committee recommend for the demonstration of quoted model of equipment by the following technically qualified bidders: -
