M/s Quest Laboratories Private Limited, situated at Plot No-45, Sector-3, Pithampur-454775, District-Dhar, Madhya Pradesh was declared as L1 bidder for the below mentioned Drugs vide tender reference no.- BMSIC/DRUGS/23-14 & BMSIC/DRUGS/23-16 respectively: -

1. Diethylcarbamazine Tablets 100mg & Glucose Powder (Food Grade) for OGTT test 75gm.

It came to notice of BMSICL that **M/s Quest Laboratories Private Limited is** Blacklisted from 01-10-2021 to 30-09-2024 by Karnataka State Medical Supplies Corporation Limited, vide Order HFW/KSMSCL/QC/01/2021-22 dated 14-09-2023 which renders you ineligible to participate in the tender under reference of BMSICL. In spite of that, you have not only participated in the tender reference, but also concealed the fact of Blacklisting. BMSICL vide letter no- BMSIC/40030/139-2024/10066, dated 21-02-2024 & BMSIC/40030/139-2024/8928, dated 24-01-2024 issued show cause notices against which the replies were found to be unsatisfactory.

As per Clause 27 A of the Standard Bidding Document, "BLACKLISTING OF PRODUCT/TENDERER ON WITHDRAWAL OF TENDER- If the Tenderer fails to execute the agreement / to deposit performance security / to perform the obligations under the tender conditions / commits default in the performance of the contract/agreement, such Tenderers will be blacklisted for a period of 2 years by BMSICL from the date of intimation besides forfeiture of EMD/Performance Guarantee. The Tenderers who have withdrawn after participating in the tender either fully or partially, the entire firm/company will be blacklisted for a period of 2 years from the date of intimation by BMSICL apart from forfeiture of the Security Deposit/EMD."

As per Clause 14 d of the Standard Bidding Document, "If at any stage, it is found that the tender has been successfully obtained by the bidder by submitting forged/fabricated certificates/documents/licenses and/or concealing by the fact about blacklisting/debarring/de-registration the firm by India/Suspension/Cancellation/non-renewal of the manufacturing license of the bidder firm, the tender bid/rate contract may be rejected/terminated and suitable punitive action may be taken against the firm."

As per Clause 3 n of the Standard Bidding Document: "The tenderer should give an affidavit (with stamp) sworn before first class magistrate / Notary stating that the firm & its quoted product is not black listed currently (as on the date of submission of the tender) by Central Government / Central Government BID-DRUGS TENDER 7 agencies/any state government or any of the state government agencies / or any Drug procurement agencies or by BMSICL asper Annexure-II."
