बिहार चिकित्सा सेवाएँ एवं आधारभृत संरचना निगम लिमिटेड द्वारा विभिन्न प्रकार के औषधियों का दर अनुबन्ध करने हेत् दिनांक 20/09/2017 को निविदा संख्या BMSIC/DRUGS/17-08 का प्रकाशन विभिन्न समाचार पत्रों में किया गया। निविदा सूचना में उल्लेखित कार्यक्रम के अनुसार दिनांक 05/10/2017 को इच्छक निविदादाताओं की निविदा पूर्व (Pre-Bid) बैठक आयोजित की गई। Pre-Bid बैठक के आलोक में कतिपय संशोधनों को सम्मिलित करते हुए ई-निविदा के माध्यम से निविदा जमा करने की अंतिम तिथि 04 / 11 / 2017 तक विस्तारित की गई।

- निविदा जमा करने की अंतिम तिथि तक कुल 28 निविदादाताओं की निविदाएँ ई—निविदा के माध्यम से प्राप्त हुई। सभी प्राप्त तकनीकी निविदाओं का मूल्यांकन प्रपत्र BMSICL में प्रतिनियक्त औषधि निरीक्षको द्वारा तैयार कर निगम के वेबसाईट पर प्रकाशित किया गया, जिसके विरूद्ध निविदादाताओं से स्पष्टीकरण एवं प्राप्त संलग्न कागजातों की जाँच कर प्रतिनियुक्त औषधि निरीक्षकों की टीम द्वारा तुलनात्मक विवरणी तैयार की गई। दिनांक 20.02.2018 को आयोजित बैठक में उक्त तुलनात्मक विवरणी की समीक्षा के क्रम में पाया गया कि कतिपय निविदादाताओं द्वारा कोई स्पष्टीकरण नहीं दिया गया है। अतः सभी निविदादाताओं को एक और अंतिम अवसर प्रदान करते हए ई० मेल के माध्यम से सुचित करने का निर्णय लिया गया।
