As per minutes of the Tender opening meeting dated 17.01.18 it was unanimously decided to recommend for Re-tender for the NIT S.N-2 & 3 due to single bid & no bid condition respectively. Retender has been floated for the said Kits vide no. BMSIC/DRUGS/18-02, accordingly.

The Preliminary Evaluation of technical bids of the above mentioned bidding firms for NIT SI no.1 (Hb Testing Kits (Haemoglobin Colour Scale Kits) was done by the team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and clarifications were invited from the respective firms vide no.651 dated 17.05.2018.

After comparison of the clarifications received from the bidders and examination of the documents submitted by the bidding firms, the TEC in its meeting dated 01.10.2018 found that proper decision was difficult to arrive at in view of the ambiguity in evaluation sheets prepared by the old team of Drug Inspectors. Hence it was decided to get the technical bids re-evaluated by the new team of Drug Inspectors.

Accordingly the bids were reevaluated by a team of drug inspectors in the light of the clarification/objection received against the preliminary evaluation sheets.

The bidder wise technical evaluation findings (as annexed) have been recorded as follows:

Allied Health sciences Pvt Ltd

i) Import licence in Form MD-15 as per clause 3(g) not submitted.

ii) Market standing certificate of minimum 3 years issued by Drug control Department as per clause 3(h) is not submitted.

iii) Non conviction certificate issued by concerned licencing authority from Drug Control Administration of state for last 3 years as per clause 3(i) is not submitted.

iv) COPP as per clause 3(j) is not submitted.

Plasti Surge Industries Pvt Ltd

i) Manufacturing licence in form MD-5 as per clause 3(f) is not submitted.

ii) Market standing certificate of minimum 3 years issued by Drug control Department as per clause 3(h) is not submitted.

iii) Non conviction certificate issued by concerned licencing authority from Drug Control Administration of state for last 3 years as per clause 3(i) is not submitted.

iv) WHO GMP/GMP as per clause 3(j) is not submitted.

v) Maximum Production Capacity Certificate as per Clause 3(k) is not submitted.

The said quoted item Hb testing kits (Hemoglobin colour scale kits) has been included in the list of invitro diagnostics Medical Devices (G.S.R. 78 E dated 31st Jan 2017), under provision of sub rule (2) Rule 4 of the MDR 2017 (Enumerated at S.no- 22 of DCG(I) notice no-DC(292) dated 01-11-2017.) Thus, Rules regarding Medical Devices is applicable. Hence the clarification submitted by the bidders doesn't comply with the clause contained as per SBD."
