The Financial Evaluation Committee Meeting for Financial Opening of the technically qualified bids received vide tender BMSIC/DRUGS/18-01 was held on 25th July 2018 under the chairmanship of Managing Director, BMSICL. The other committee members present in the meeting are:

As per the minutes of the meeting of the Technical opening of the bid, it was recommended for retendering the single bid or zero bid drug, which is in EDL-2018. Drugs at serial number 8 & 35 for which multiple bids have been received are not in EDL-2018, hence it was decided not to evaluate the bids for these drugs. Both the firm have clarified through e-mail also that they have quoted Atenolol tablets 25mg@ per 100 tablets (exclusive of GST). As both the firms have quoted the rate Per Packet it was therefore decided unanimously to correct the quoted rate to the extent of per tablet rate as per their clarification. And accordingly it was decided to issue LOI to the L1 bidder as mentioned above.
