For Rapid Plasma Reagin Kits, M/s Alere Medical Pvt. Ltd. has been **disqualified technically and** only M/s Mediclone Biotech Private Ltd has qualified.

For Whole Blood Finger prick test for HIV Kits, M/s Alere Medical Pvt Ltd & M/s Nectar Life sciences Ltd has been disqualified technically and only M/s Meril Diagnostics Pvt Ltd. has qualified.

For both the kits after evaluation of the bids single bidder has been qualified technically but since this is a Re-tender hence it was unanimously recommended to proceed further as per the provisions contained in the Notification Number 7806 Dated 30.09.2016 of Finance Department, Government of Bihar and recommended for opening of the financial bid for above two firms subject to satisfactory factory inspection report.
