

MINUTES OF FINANCIAL OPENING COMMITTEE MEETING OF TENDER NO. BMSIC/MEDICAL DEVICES/CONSUMABLES/18-02 (RATE CONTRACT AND SUPPLY OF MEDICAL DEVICES/CONSUMABLES FOR DIFFERENT HEALTHCARE FACILITIES OF STATE OF BIHAR 2018-2020).

Date: 09th April 2019

Venue: BMSICL Conference Hall.

The **Financial Opening Committee Meeting of tender BMSIC/MEDICAL DEVICES/ CONSUMABLE/18-02** was held on 09th April 2019 under the Chairmanship of Managing Director, BMSICL. The other committee members present in the meeting were:

2. The Details of the invited tender are as follows:

1. Tender Reference No. BMSIC/MEDICAL DEVICES/ CONSUMABLE/18-02
2. Tender floated date- 17/11/2018
3. Last date of submission of Online bids-19/12/2018
4. Tender Opening date- 21/12/2018

3. Tender was floated for 09 MEDICAL DEVICES/ CONSUMABLES. It was found in the online opening that following 03 (Three) bidders had participated in the tender:

- i) M/s Amkay Products Pvt. Ltd.
- ii) M/s Primewear Hygiene (India) Products Ltd.
- iii) M/s Plasti Surge Industries Pvt. Ltd.

4. The summary of Bid received status is as follows:

1. No Bid received for 5 MEDICAL DEVICES/ CONSUMABLES.
2. Multiple Bids received for 4 MEDICAL DEVICES/ CONSUMABLES.

5. It was therefore unanimously decided in tender opening meeting dated 21.12.2018 to proceed further to get the preliminary evaluation done by the team of Drug Inspectors deputed at BMSICL for this purpose, of all the bids for **those 4 MEDICAL DEVICES/ CONSUMABLES (NIT SN- 2,3,6 &7)** for which multiple bids have been received and retender for **those 5 MEDICAL DEVICES/ CONSUMABLES (NIT SN- 1,4,5,8 & 9)** for which no bid was received.

6. Accordingly the Preliminary Evaluation of technical bids of the above mentioned 3 (Three) bidding firms was done by the team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published

on the website of BMSICL and clarifications/Objections were invited from the respective firms vide notice no. 5041 dated 21.01.2019.

7. After comparison of the clarifications/objections received in the light of that notice and close examination of the documents submitted by the bidding firms, a firm wise comparative chart was prepared and, on that basis, the MEDICAL DEVICES/ CONSUMABLES wise technical evaluation findings were recorded by the TEC in its meeting dated 11.02.2019 as follows:
