As per Tender opening minutes of the meeting dated 03.08.2018, the Technical Evaluation Committee has recommended for Re-tender of 72 drugs (NIT SN-1,2,5,6,7,8,9,10,11,12,14,15, 17,20,22,23,24,25,26,27,28,31,32,34,37,38,39,40,42,50,52,53,54,55,56,57,59,60,61,62,63,65,66,67, 69, 70, 71, 72, 75, 76, 77, 79, 81, 83, 84, 85, 86, 88, 89, 90, 93, 94, 95, 98, 100, 101, 102, 103, 106, 107, 108 & 110) due to no bid condition and to evaluate only those 28 drugs (NIT SN- 3,4,13,16,19,29, 30, 33, 35, 43, 44, 45, 47, 58, 64, 68, 74, 80, 82, 87, 91, 92, 96, 97, 99, 104, 105 & 109) for which Single bids have been received, as this being a retender and 10 drugs (NIT SN-18, 21, 36, 41, 46, 48, 49, 51, 73 & 78) for which multiple bids have been received.

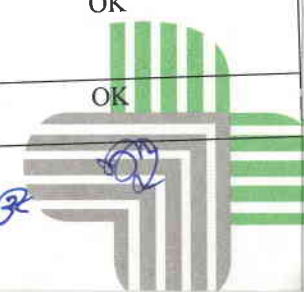
6. The Preliminary Evaluation of technical bids of the above mentioned bidding firms was done by the team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and clarifications were invited from the respective firms.

7. After comparison of the clarifications received from the bidders and close examination of the documents submitted by the bidding firms, the drug wise technical evaluation findings have been recorded as follows: -

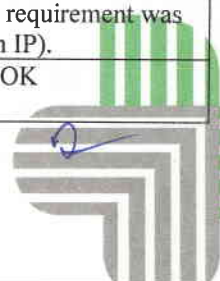

8. The Clause 2(d) of Standard Bidding Documents states that, "In order to ensure procurement of the tendered drugs at the most appropriate and competitive rate, the bidders are directed to quote their lowest price as compared to the Rates provided to their respective Distributors/Dealers/ Wholesalers/Carrying and Forwarding Agents/Authorized depot sales point in the State of Bihar. A Notarized affidavit to this effect on a Rs 100/- Non-Judicial Stamp Paper should be submitted with the Bid". The firm M/s Mercury Laboratories Ltd. & M/s Biological E Ltd. have not submitted the requisite affidavit. Hence it was unanimously decided to intimate the said firms for submission of the requisite affidavit within 7 days. For non-submission of the affidavit the firm will be considered as disqualified.

9. The firm M/s Unimarck Pharma India Ltd has quoted for the drug Drotaverine Hydrochloride Injection I.P 40mg/2ml, according to Old Product list (Annexure-II of NIT). As per Corrigendum-I dated 25/07/2018 the concerned drug has been omitted from the list, hence the firm and its product were not recommended for further evaluation.


10. It was unanimously recommended to open the financial Bids quoted for the drugs having NIT S.N.-18, 36, 41, 46, 49, 51, 73 & 78 for which multiple bidders have been qualified technically subject to Satisfactory Factory inspection report.

11. Since this Tender is a Re-tender, it was unanimously recommended to proceed further as per the provisions contained in the Notification Number 7806 Dated 30/09/2016 of Finance Department, Government of Bihar for NIT S.N.- 13, 21, 29, 30, 33, 35, 43, 44, 47, 58, 64, 68, 74, 80, 82, 87, 92, 99, 104, 105 & 109 for which single bidder has been qualified technically, subject to Satisfactory Factory inspection report.

12. It was unanimously decided to recommend for Re-tender for the 08 drugs (NIT S.N. 3, 4, 16, 19, 45, 48, 91, & 97) for which multiple bids/ single bid had been received but the bidders could not qualify technically resulting into zero bid condition.
