## **Order**

M/s Ridley Life Sciences Private Limited, situated at D-1615, DSIDC, Industrial Complex Narela, New Delhi- 110040 was declared as L1 bidder for the below mentioned Drug vide tender reference no.- BMSIC/DRUGS/22-08:-

 Phenytoin Sodium Oral Solution 25mg/ml Oral Solution Bottle (with unit price of Rs. 12.06/-)

Accordingly, M/s Ridley Life Sciences Private Limited was issued a Letter of Intent (LoI) vide letter no.- 6254, dated 28-10-2022 for submitting the requisite documents, security deposit and to execute the Rate-Contract for the said drug within 10 days from the date of receipt of LoI, i.e by 07-11-2022.


Subsequently, M/s Ridley Life Sciences Private Limited was issued show cause for above mentioned drug item vide letter no.8112 dated 18.01.2023 and through mail on dated 06.02.2023. In spite of show cause issued by BMSICL, the firm M/s Ridley Life Sciences Private Limited has not replied.

As per Clause 21 1 of the Tender Document, "The supplier shall submit agreement, the hard-copies of the documents submitted and other documents specified, copy of LOI duly signed and sealed on all pages in token of acceptance and the required Security Deposit within 15 days."

Clause 27 A of the Tender Document is relevant for such cases which reads as: "If the Tenderer fails to execute the agreement / to deposit performance security / to perform the obligations under the tender conditions / commits default in the performance of the contract/agreement, such Tenderers will be blacklisted for a period of 2 years by BMSICL from the date of intimation besides forfeiture of EMD/Performance Guarantee. The Tenderers who have withdrawn after participating in the tender either fully or partially, the entire firm/company will be blacklisted for a period of 2 years from the date of intimation by BMSICL apart from forfeiture of the Security Deposit/EMD."

Hence in view of the violation of provisions contained in Clause 21.1 of the Tender document and on account of failure to enter into agreement after issuance of Letter of Intent (LoI) and failure to perform the obligations contained in Clause 27 A vide Tender reference no-BMSIC/DRUGS/22-08, M/s Ridley Life Sciences Private Limited, situated at D-1615, DSIDC, Industrial Complex Narela, New Delhi- 110040 is hereby blacklisted for its quoted product Phenytoin Sodium Oral Solution 25mg/ml Oral Solution Bottle" for a period of two (02) years from the date of issue of this order. The EMD/Performance Guarantee submitted by the firm for the said item shall also stand forfeited in accordance with the terms and conditions of the contract
