

**MINUTES OF TECHNICAL EVALUATION COMMITTEE MEETING FOR TENDER NO.-  
BMSIC/MEDICAL DEVICES/CONSUMABLES/21-07 (TENDER FOR RATE CONTRACT AND  
SUPPLY OF HOME BASED NEW BORN CARE (HBNC) KITS FOR DIFFERENT HEALTHCARE  
FACILITIES OF STATE OF BIHAR.**

**Date: 15<sup>th</sup> July 2021**

**Venue: BMSICL Conference Hall.**

The **Technical Evaluation Committee Meeting for Tender No. BMSIC/MEDICAL DEVICES/CONSUMABLES/21-07** was held on **15<sup>th</sup> July 2021** under the Chairmanship of Dr. Navin Chandra Prasad, Director in Chief, Department of Health, GoB. The other committee members present in the meeting were:

**2. The Details of the invited tender are as follows:**

1. Tender Reference No. BMSIC/MEDICAL DEVICES/CONSUMABLES/21-07
2. Tender floated date- 19/02/2021.
3. Last date of submission of Online bids- 19/03/2021.

**3. The Tender has been floated on e-proc Portal for 7 (Seven) components of Home Based New Born Care (HBNC) Kits.**

**4. Total 03 bidders were found to have successfully submitted their bids on the e-proc online system. The submission status of hard copy of the technical bids including the tender fee and Earnest Money Deposit (EMD), till the stipulated time was found as following: -**

**5. The firm M/s Sysmed Exim Private Ltd neither submitted the hardcopy nor considered by the online e-proc system. Accordingly, it was unanimously decided by TEC in its meeting dated 05.07.2021 to recommend for considering only those above mentioned 03 bidders (Sl. No. 1 to 03) who have successfully submitted their bids online as well as Earnest Money Deposit (EMD) & Tender fee, for further technical evaluation process.**

**6. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 2515 dated 10.07.2021.**

7. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, it was observed by TEC in its meeting dated 14.07.2021 that all the three bidders namely, M/s Laxmi International, M/s Plasti Surge Industries Pvt. Ltd. & M/s Variety Vyapaar Private Ltd. were unable to submit the Certificate regarding **conformity to BIS standard for Digital watch, Digital Thermometer, Neonatal weighing scale- Tubular spring type with sling & LED Torch with 3 cells**. The firm M/s Variety Vyapaar Private Ltd. has submitted in its clarification that BIS does not issue the **Certificate regarding conformity to BIS standard for Digital watch, Digital Thermometer, Neonatal weighing scale- Tubular spring type with sling & LED Torch with 3 cells** as there is no BIS standard for these items. Hence it was unanimously decided by TEC in its meeting dated 14.07.2021 to ask from the Patna office of BIS regarding availability of Indian standard for above mentioned product. It was also decided in that TEC meeting to sit again after getting the response from BIS.

8. Accordingly the meeting was held today. The members were apprised of the fact that BIS Patna office has clarified through mail dated 15.07.2021 (Annexed herewith) that there is no BIS standard available for the items namely 1) **Digital watch** 2) **Digital Thermometer** 3) **Neonatal weighing scale- Tubular spring type with sling** and 4) **LED Torch with 3 cells**. Hence it was unanimously decided that the bid condition regarding conformity to BIS standards should not be applicable to these items and accordingly all the three participating firms were declared to be technically qualified. It was therefore unanimously decided to recommend for opening of the financial bids of the technically qualified bidders on e -proc Portal.
