7. The summary of Bid received status is as follows:

1. No Bids received for **04** items.
2. Single Bids received for **17** items.
3. Multiple Bids received for **15** items.

8. It was therefore unanimously decided by the TEC in its meeting dated 19.01.2022 to recommend for Re-tender of Drugs at NIT SN- 21, 24, 26 & 36 (**04** Drugs) due to no bid condition and NIT SN- 4, 6, 7, 8, 9, 10, 11, 15, 16, 18, 19, 22, 23, 28, 32, 33 & 35 (**17** Drugs) due to Single bid condition and to evaluate the bids for **those 15 Drugs** (NIT SN- 1, 2, 3, 5, 12, 13, 14, 17, 20, 25, 27, 29, 30, 31 & 34) for which multiple bid has been received.

9. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 8657 dated 10.02.2022.

10. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings by the TEC in its meeting dated 18.02.2022 were recorded as follows:

It was found during Technical Evaluation Committee Meeting dated 18.02.2022, the product at NIT Sl No. 27 (Promethazine Injection 25mg/ml 1 ml Vial) quoted by M/s Pushkar Pharma was not evaluated during Preliminary technical evaluation, hence the said product was evaluated and Technical Evaluation status was mentioned above at Sl. No. 11 of the comparative chart.

12. As per the above comparative chart Twenty four (24) bidders namely, M/s Zenith Drugs Pvt. Ltd., M/s ANG Life Sciences India Ltd, M/s Apple Formulations Private Limited, M/s Arion Healthcare, M/s Ciron Drugs & Pharmaceuticals Pvt Ltd, M/s Tirupati Medicare Ltd, M/s Health Biotech Limited, M/s Macleods Pharmaceuticals Limited, M/s Alpa Laboratories Limited, M/s Mascot Health Series Pvt. Ltd., M/s Nanz Med Science Pharma (p) Ltd., M/s Navkar Lifesciences, M/s Marc Laboratories Limited, M/s Ornate Labs Pvt Ltd, M/s Samarth Life Sciences Pvt. Ltd., M/s Preet Remedies Ltd., M/s Pushkar Pharma, M/s Abbott India Limited, M/s Ridley Life Science Pvt Ltd, M/s Saar Biotech, M/s Shamshree Lifesciences Limited, M/s Unicure India Limited, M/s Ultra Drugs Private Limited & M/s Verve Human Care Laboratories were found technically qualified notwithstanding their product wise qualification status as mentioned above. It was therefore unanimously decided by the TEC in its meeting dated 18.02.2022 to recommend for uploading the bidder wise technical qualification status (Qualified/ Disqualified) on BMSICL website (www.bmsicl.gov.in) to submit their representation through BMSICL e-mail Id (contact2bmsicl@gmail.com) against disqualification within one (01) week and sit again.
