M/s Shree Chitranjan Meditech & Fragrance Pvt Ltd., situated at Industrial Area, Fatuha, Patna, Bihar has participated in Tender No. - BMSIC/Medical Devices/Consumables/21-12 for the procurement of Cotton & Bandages.

As per Clause 3f of the Tender document, "Bidders must have:- Valid Pollution Control Clearance Certificate in accordance with Water [Prevention and control of Pollution] Act, 1974 & Air [Prevention and control of Pollution] Act, 1981 and Hazardous Wastes (Management, Handling & Trans Boundary Movement) Rules 2008 (Self Attested Copy of Certificate to be enclosed) (as applicable)," against which the firm submitted discharge consent order, issued by Bihar State Pollution Control Board vide Ref No- P/T 2-94/20-/T-9257 dated 22-04-2023, which was sent to Bihar State Pollution Control Board for verification and was found to be forged, vide Letter No-2772 dated 17-08-2022 of Bihar State Pollution Control Board, Patna.

As per ANNEXURE-IV of Bid document the firm, M/s Shree Chitranjan Meditech & Fragrance Pvt Ltd has submitted an affidavit (Acceptance of tender conditions) in where it is stated that, "The information / documents furnished along with the above application are true and authentic to the best of my knowledge and belief. I / we, am / are well aware of the fact that furnishing of any false information / fabricated document would lead to rejection of my tender at any stage besides liabilities towards prosecution under appropriate law."

Tender clause 27 A stipulates that, "If the Tenderer fails to execute the agreement / to deposit performance security / to perform the obligations under the tender conditions / commits default in the performance of the contract/agreement, such Tenderers will be blacklisted for a period of 2 years by BMSICL from the date of intimation besides forfeiture of EMD/Performance Guarantee. The Tenderers who have withdrawn after participating in the tender either fully or partially, the entire firm/company will be blacklisted for a period of 2 years from the date of intimation by BMSICL apart from forfeiture of the Security Deposit/EMD".

BMSICL vide Letter No. – BMSIC/40025/350-2021/3887 dated 07-09-2022 and BMSIC/40025/350-2021/4618 dated 30/09/2022, issued Show Cause notices to M/s Shree Chitranjan Meditech & Fragrance Pvt Ltd, against which reply has not been received yet.

Hence, in view of the violation of provisions contained in Clause 3f and 27 A of the Tender document, vide Tender No. - BMSIC/Medical Devices/Consumables/21-12, M/s Shree Chitranjan Meditech & Fragrance Pvt Ltd, situated at Industrial Area, Fatuha, Patna, is hereby blacklisted for a period of two (2) years from the date of issue of this order, beside forfeiture of EMD/Performance Guarantee.
