

M/s Voxtur Bio Ltd, situated at Plot No- A-1, Royal Compound, Kaman, Tamanmal Kaman Bhiwandi Road, Tal. Vasai, Palghar-401208, Maharastra has participated in Tender No - BMSIC/MEDICAL DEVICES/CONSUMABLES/22-03 and was technically qualified for the following items:-

- (i) HIV (Rapid) Kits 1st Antigen
- (ii) HIV (Rapid) Kits 2nd Antigen
- (iii) Whole Blood Finger Prick HIV Test Kits
- (iv) Antisera A (Monoclonal, IgM)- 10 ml Vial
- (v) Antisera B (Monoclonal, IgM)- 10 ml Vial
- (vi) Antisera D (Monoclonal IgM + IgG Blend)- 10 ml Vial.
- 2. Subsequently, the firm M/s Voxtur Bio Ltd was declared L1/L2 for the following items:-
- (i) HIV (Rapid) Kits 1st Antigen (L1)
- (ii) HIV (Rapid) Kits 2nd Antigen (L1)
- (iii) Whole Blood Finger Prick HIV Test Kits (L1)
- (iv) Antisera A (Monoclonal, IgM)- 10 ml Vial (L1)
- (v) Antisera B (Monoclonal, IgM)- 10 ml Vial (L1)
- (vi) Antisera D (Monoclonal IgM + IgG Blend)- 10 ml Vial (L2)
- 3. Now it has come to the notice of BMSICL that M/s Voxtur Bio Ltd is debarred by MPPHCL (Madhya Pradesh Public Health Services Corporation Limited), Bhopal for two years vide Order No-3940 dated 12-05-2022 for non- execution of Rate Contract, which renders you ineligible to participate in the tender under reference of BMSICL. In spite of that, you have not only participated in the tender under reference, but also concealed the fact of debarment. BMSICL vide Letter No- BMSIC/40030/10-2022/7023 dated 01-12-2022 issued a showcause notice against which the reply is still awaited.
- 4. As per Clause No. 27 A of Standard Bid Document: BLACKLISTING OF PRODUCT/TENDERER ON WITHDRAWAL OF TENDER- "If the Tenderer fails to execute the agreement / to deposit performance security / to perform the obligations under the tender conditions / commits default in the performance of the contract/agreement, such Tenderers will be blacklisted for a period of 2 years by BMSICL from the date of intimation besides forfeiture of EMD/Performance Guarantee. The Tenderers who have withdrawn after participating in the tender either fully or partially, the entire firm/company will be blacklisted for a period of 2 years from the date of intimation by BMSICL apart from forfeiture of the Security Deposit/EMD."
- 5. As per Clause No. 14 d of Standard Bid Document, "If at any stage, it is found that the tender has been successfully obtained by the bidder by submitting forged/fabricated certificates/documents/licenses and/or by concealing the fact about blacklisting/debarring/deregistration of the firm by Govt. of India/Suspension/Cancellation/non-renewal of the manufacturing license of the bidder firm, the tender bid/rate contract may be rejected/terminated and suitable punitive action may be taken against the firm."

6. As per Clause No. 3 m of Standard Bid Document, "The tenderer should give an affidavit sworn before first class magistrate / Notary stating that the firm & its quoted product is not black listed currently (as on the date of submission of the tender) by Central Government / Central Government agencies/any state government or any of the state government agencies / or any Drug procurement agencies or by BMSICL as per Annexure-II."

7. Hence in view of the violation of provisions contained Tender document vide ref. no-BMSIC/MEDICAL DEVICE/CONSUMABLES/22-03, M/s Voxtur Bio Ltd is hereby blacklisted for a period of two years from the date of issue of this order apart from forfeiture of the Security Deposit/EMD."
