9. The Preliminary Evaluation of technical bids from the aforementioned bidding firms was conducted by the assigned team, including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the BMSICL website, and claims/objections were invited online vide notice no. 1581 dated 27/05/2024 on e-proc2.

10. After evaluating the clarifications received from the bidders in response to the notice and closely examining the documents submitted by the firms, the technical evaluation findings for each firm were recorded in today's meeting as follows:

Ltd., M/s CMG Biotech Private Limited, M/s Encube Ethicals Private Limited, M/s Farista Vanijya Private Limited, M/s Hindustan Medicines Private Limited, M/s Ipca Laboratories Limited, M/s Johnson and Johnson Private Limited, M/s Kras Pharmaceuticals Private Limited, M/s Mankind Pharma Limited, M/s Mylan Laboratories Limited, M/s Ramson Remedies, M/s Reliance Life Sciences Pvt. Ltd., M/s Sanofi India Limited, M/s Unicare India Limited & M/s Unimarck Healthcare Limited were found technically qualified notwithstanding their product wise qualification status as mentioned above.

Ltd., M/s CMG Biotech Private Limited, M/s Farista Vanijya Private Limited, M/s Hindustan Medicines Private Limited, M/s Ipca Laboratories Limited, M/s Kras Pharmaceuticals Private Limited, M/s Ramson Remedies, M/s Reliance Life Sciences Pvt. Ltd., M/s Unicare India Limited & M/s Unimarck Healthcare Limited were inspected during last three years and/or having valid rate contact with BMSICL.

14. A total of two (02) technically qualified firms namely, M/s Johnson and Johnson Private Limited & M/s Sanofi India Limited are importer.

15. It was therefore unanimously decided to recommend for factory inspection of remaining Three (03) technically qualified firms namely, M/s Encube Ethicals Private Limited, M/s Mankind Pharma Limited & M/s Mylan Laboratories Limited.
