As per the minutes of the meeting of the Technical opening of the bid, it was recommended for retendering the single bid or zero bid drug, which is in EDL-2018. For NIT SI No. 25 (Phenytoin Sodium Injection IP) M/s Daffodills Pharmaceuticals Pvt Ltd. has been disqualified Technically and only M/s Ciron Drugs & Pharmaceuticals Pvt Ltd. is Qualified Technically. For NIT SI No. 36 (Vecuronium Injection IP 4 mg/ 2ml Ampoule) M/s Celon Laboratories Pvt Ltd. has disqualified Technically and only M/s Ciron Drugs & Pharmaceuticals Pvt Ltd.is qualified Technically.

It was decided to recommend retender for these two drugs, due to single bid condition as per Notification No.7806 Dated 30.09.2016 of Finance Department, Govt.of Bihar. And at the same time it was also decided to recommend for opening of financial Bid of the above mentioned qualified firms.
