

**MINUTES OF FINANCIAL OPENING COMMITTEE MEETING FOR TENDER NO. BMSIC/MEDICAL DEVICES/CONSUMABLE/18-03(RATE CONTRACT AND SUPPLY OF MEDICAL DEVICES/CONSUMABLE FOR DIFFERENT HEALTHCARE FACILITIES OF STATE OF BIHAR: 2018-2020).**

**Date: 26<sup>th</sup> August 2019**

**Venue: BMSICL Conference Hall.**

The Financial Opening Committee Meeting of tender No. BMSIC/MEDICAL DEVICES/CONSUMABLE/18-03 was held on 26<sup>th</sup> August 2019 under the Chairmanship of Managing Director, BMSICL. The other committee members present in the meeting were:

**2. The Details of the invited tender are as follows:**

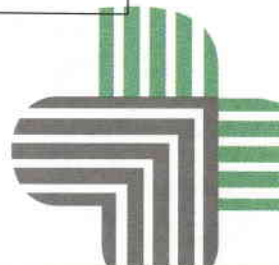
1. Tender Reference No. BMSIC/MEDICAL DEVICES/ CONSUMABLE/18-03.
2. Tender floated date- 28/11/2018.
3. Last date of submission of Online bids-17/01/2019.
4. Tender Opening date- 18/01/2019.

3. Tender has been floated for 2(Two) Kits i.e. Salt Testing Kit and Haemoglobin Color Scale Kit. It was found in online opening that following 2 (Two) bidders had participated in the tender:

1. M/s Allied Healthsciences Pvt. Ltd.
2. M/s Plasti Surge Industries Pvt. Ltd.

**4. The kit wise bid received status were as follows:**

It was unanimously decided in tender opening meeting dated 18.01.2019 to proceed further for preliminary technical evaluation for Hb Testing Kits (Haemoglobin Colour Scale Kits) (NIT SI no.2) for which multiple bids have been received, by the team of Drug Inspectors deputed at BMSICL and Re-tender of Salt Testing Kit (NIT SI no.1) for which single bid has been received.
6. Accordingly, the preliminary evaluation of the received technical bids of the above mentioned bidding firms for Hb Testing Kits (Haemoglobin Colour Scale Kits) (NIT SI no.2) was done by the team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL & Clarification were invited from the respective firms vide notice no.6240 dated 08.03.2019.
7. In the published preliminary evaluation sheets, prepared by the team of Drug Inspectors, Hb Testing Kit (Haemoglobin Colour Scale Kit) was evaluated under Non-Drug category. But the said product had been floated vide the previous tender BMSIC/DRUGS/17-13 & was evaluated under Drug category by the team of Drug Inspectors those were previously deployed at BMSICL.

In view of the above ambiguity in evaluation sheets prepared by the team of Drug Inspectors, it was difficult to draw any conclusion by the TEC. Hence the TEC in its meeting dated 26.03.19 recommended to invite the technical opinion from State Drug Controller, GoB regarding the category under which the said product belongs i.e., whether the product comes under the purview of Drug or Non-Drug category & accordingly the technical bids shall be re-evaluated by a new team of Drug Inspectors.

8. The technical opinion has been invited from the State Drug Controller, GoB vide letter no.1172 dated 10.06.2019. The technical opinion has been received from the State Drug Controller, GoB by their office letter no.785(15) dated 02.07.19. After perusal of which the TEC in its last meeting unanimously recommended to re-evaluate the technical bids by a new team of Drug Inspectors under the purview of Non-Drug category.
9. Accordingly, both the technical bids were re-evaluated by the new team of Drug Inspectors deputed at BMSICL. After perusal of the re-evaluated checklist, technical bids & clarifications, the Kit wise technical evaluation findings were recorded by the TEC in its meeting dated 23.07.2019 as follows:

10. The bid validity for this tender no. BMSIC/MEDICAL DEVICES/ CONSUMABLE/18-03 was valid upto 17.07.19. Both the bidders were requested to extend their bid validity for a further period of six months from the date of expiry i.e., 17.07.19, vide letter no. 1958 dated 16.07.2019. Both the bidders were given their consent for extension of the bid validity for next six months.

11. It was unanimously recommended by TEC in its last meeting dated 23.07.2019 to intimate both the bidders i.e., M/s Allied Healthsciences Pvt. Ltd & M/s Plasti Surge Industries Pvt. Ltd. to be present in front of this committee on 13.08.2019 at 11:00 AM in BMSICL conference hall along with all original documents i.e., documents in support of the remarks as mentioned in the above table, documents submitted during online submission & clarification.

12. Both the concerned firms were intimated accordingly to attend the TEC meeting dated 13.08.19 vide letter no. 2533 dated 08.08.2019.

13. All the original document i.e., documents in support of the remarks as mentioned in the above table, documents submitted during online submission & clarification of both the bidders were verified during the TEC meeting dated 13.08.19 & both the bidders were declared technically qualified. Hence it is unanimously recommended by the TEC for opening of the financial bids of both the Technically Qualified firms.

14. Accordingly, in today's meeting financial bids of both the firms i.e. M/s Allied Healthsciences Pvt. Ltd. & M/s Plasti Surge Industries Pvt. Ltd. were opened online on E-Proc.

15. After opening of the financial bids (downloaded copies annexed as Annexure I) the rates quoted by both the technically qualified bidders were found as following and after comparison of which the bid ranking status is recorded as below: -
