7. The summary of Bid received status was as follows:

1. No Bids received for **02** Drugs.
2. Single Bids received for **01** Drug.
3. Multiple Bids received for **11** Drugs.

8. It was therefore unanimously decided by TEC in its meeting dated 24.07.2023 to recommend for Re-tender of Drugs at NIT S.N.- 1 & 12 (**02 Drugs**) due to no bid condition & NIT S.N.- 7 (**01 Drug**) due to Single bid condition and to evaluate the bids for **those 11 Drugs** (NIT S.N.- 2, 3, 4, 5, 6, 8, 9, 10, 11, 13 & 14) for which multiple bids have been received.

9. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 4906 dated 13.09.2023.

10. Meanwhile, since the manufacturing unit of the Six (06) firms namely, M/s Cipla Limited, M/s Scott Edil Pharmacia Ltd, M/s Rampion Laboratory, M/s Ramson Remedies, M/s Ravian Life Science Private Limited & M/s Mancare Laboratories Private Limited were not inspected during last three years and are not having valid Rate Contract with BMSICL, hence the factory inspection of all the six firms was conducted by the team of Drug Inspectors deputed at BMSICL. After comparison of the clarification received from the bidders in light of Notice no. 4906 dated 13.09.2023 and perusal of Factory inspection reports and also close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings by TEC in its meeting dated 31.10.2023 were recorded with the help of the Drugs Inspectors deputed at BMSICL as follows:
