7. The firm, M/s Live Well Healthcare had not submitted Annexure III (List of items quoted) online on eproc2. In Annexure II (Affidavit for non-blacklisting) also, the firm hadn't provided the list of items quoted, but have simply written "all quoted products".

**8. The summary of Bid received status was as follows:**

1. No Bid received for **01** Drug.
2. Single Bids received for **02** Drugs.
3. Multiple Bids received for **26** Drugs.

9. It was therefore unanimously decided to recommend for Re-tender of Drug at NIT S.N.- 25 due to no bid condition & NIT S.N.- 2 & 22 due to single bid condition and to evaluate the bids for **those 26 Drugs** (NIT S.N.- 1, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 23, 24, 26, 27, 28 & 29) for which multiple bids have been received.

10. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 7568 dated 06/12/2023.

11. Meanwhile, since the manufacturing unit of the Seven (07) firms namely, M/s Aishwarya Lifesciences, M/s Live Well Healthcare, M/s Bharat Biotech International Ltd., M/s Danish Health Care Pvt. Ltd., M/s Haseeb Pharmaceuticals Pvt. Ltd., M/s Serum Institute of India Pvt. Ltd. & M/s Vim Meditech Pvt. Ltd. were not inspected during last three years and/or not having valid Rate Contract with BMSICL, hence the factory inspection of all the seven firms was conducted by the team of Drug Inspectors deputed at BMSICL. After comparison of the clarification received from the bidders in light of Notice no. 7568 dated 06/12/2023 and perusal of Factory inspection reports and also close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings by TEC in its meeting dated 19/10/2023 were recorded with the help of the Drugs Inspectors deputed at BMSICL as follows:-
