- **8.** The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 7644 dated 08/12/2023.
- **9.** Meanwhile, since the manufacturing unit of the Five (05) firms namely, M/s Aster Medicines Pvt. Ltd., M/s Pontika Aerotech Ltd., M/s United Biotech Pvt. Ltd., M/s Troikaa Pharmaceuticals Ltd. & M/s Systochem Laboratories Ltd. were not inspected during last three years and/or not having valid Rate Contract with BMSICL, hence the factory inspection of all the five firms was conducted by the team of Drug Inspectors deputed at BMSICL. After comparison of the clarification received from the bidders in light of Notice no. 7644 dated 08/12/2023 and perusal of Factory inspection reports and also close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings by TEC in its meeting dated 19/12/2023 were recorded with the help of the Drugs Inspectors deputed at BMSICL as follows:
