7. The summary of Bid received status was as follows:

1. No Bids received for **06** Medical Devices/Consumables.
2. Single Bids received for **07** Medical Device/Consumable.
3. Multiple Bids received for **11** Medical Devices/Consumables.

8. Based on the information received via Letter No. 168 dated 12.09.2019, 5011 dated 24.09.2019, and Letter No. 388 dated 03.02.2019 from Nalanda Medical College and Hospitals, Patna, as well as the information provided to the Logistics section by various hospitals, it has been determined that the demand for Black Braided Silk 1 and 1/0 is for them to be supplied "with needle". It was therefore unanimously decided to recommend for Re-tender of Medical Devices/Consumables at NIT S.N.- 5 & 6 (**02** Medical Devices/Consumables) on the basis of letter and information received & NIT S.N.- 2, 12, 17, 18, 20 & 21 (**06** Medical Devices/Consumables) due to no bid condition & and NIT S.N.- 3, 13, 14, 15, 22, 23 & 24 (**07** Medical Devices/Consumables) due to Single bid condition and to evaluate the bids for **those 11 Medical Devices/Consumables** (NIT S.N.- 1, 4, 5, 6, 7, 8, 9, 10, 11, 16 & 19) for which 13 (Thirteen) multiple bids have been received.

9. A total of 04 (Four) bidders, namely M/s Nanz Med Science Pharma (P) Ltd, M/s Tuoren Medical Device India Private Limited, M/s S L Chemicals & Organics Private Limited & M/s Sterimed Surgicals (India) Pvt Ltd were not evaluated due to single bid condition.

10. The Preliminary Evaluation of technical bids from the aforementioned bidding firms was conducted by the assigned team, including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the BMSICL website, and claims/objections were invited online vide notice no. 10760 dated 06/03/2024 on e-proc2.

11. After evaluating the clarifications received from the bidders in response to the notice and closely examining the documents submitted by the firms, the technical evaluation findings for each firm by TEC in its meeting dated 05/04/2024 were recorded as follows:

According to the comparative chart above, a total of Eleven (11) bidders, namely M/s Advanced Medtech Solutions Private Limited, M/s Datt Mediproducts Private Limited, M/s Futura Surgicare Private Limited, M/s Goldwin Medicare Limited, M/s Healthium Medtech Limited, M/s Meril Endo Surgery Private Limited, M/s Safe Surgical Industries, M/s Shanti Surgicals Private Limited, M/s Surgical Sutures Private Limited, M/s Tulip Surgicals & M/s Zenith Corporation were found technically qualified not withstanding their product wise qualification status as mentioned above.

13. A total of Two (02) firms, namely M/s MCo Hospital Aids Private Limited & M/s Peters Surgical India Private Limited were found technically disqualified.

14. The manufacturing unit of total Seven (07) technically qualified firms, namely M/s Advanced Medtech Solutions Private Limited, M/s Goldwin Medicare Limited, M/s Healthium Medtech Limited, M/s Meril Endo Surgery Private Limited, M/s Safe Surgical Industries, M/s Shanti Surgicals Private Limited & M/s Tulip Surgicals were inspected during last three years and/or having valid rate contact with BMSICL. It was therefore unanimously decided by TEC in its meeting dated 05/04/2024 to recommend for factory inspection of remaining Four (04) technically qualified firms i.e., M/s Datt Mediproducts Private Limited, M/s Futura Surgicare Private Limited, M/s Surgical Sutures Private Limited & M/s Zenith Corporation.

15. The factory inspection of the firms i.e., M/s Datt Mediproducts Private Limited, M/s Futura Surgicare Private Limited, M/s Surgical Sutures Private Limited & M/s Zenith Corporation has been conducted by the team of Drug Inspectors deputed at BMSICL. After perusal of the Factory Inspection report, it was found that the firms i.e., M/s Datt Mediproducts Private Limited, M/s Futura Surgicare Private Limited, M/s Surgical Sutures Private Limited & M/s Zenith Corporation were technically qualified.

16. Accordingly, the financial bids of technically qualified bidders were opened today on e-proc2 Portal, in which the following result has been observed: -
