It was unanimously decided in tender opening committee meeting dated 11.01.19 to proceed further for preliminary technical evaluation of all the bids for **those 22 drugs** (NIT SN- 1,2,4,5,6,7,8,9,12,13, 14,15,16,17, 18,20, 21,22,23,24,27, and 28) for which multiple bids were received, by the team of Drug Inspectors deputed at BMSICL and retender for 8 drugs for which zero bid (NIT SN- 10,19,25,26,29 and 30) and single bids (NIT SN-3 and 11) were received.


6. The Preliminary Evaluation of technical bids of the above mentioned bidding firms was done by the team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/Objections/Clarification were invited vide notice no.5040 dated 21.01.2019.

7. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the drug wise technical evaluation findings were recorded by the TEC in its meeting dated 11.02.2019 as follows:

Regarding Blacklisting of the firm Aculife Healthcare Pvt. Ltd. by OSMCL (the Honorable Orissa High Court Order no. WP(C) 15723/2018 dated 03.09.2018 requires clarification. Hence the TEC in its last meeting dated 11.02.19 recommended for seeking legal opinion before taking the final decision on the issue of technical qualification otherwise the firm was found technically qualified for all quoted products except NIT SI no.1.

It was also recommended in that TEC meeting to carry out the factory inspection of those above mentioned firms which are technically qualified as well as of those whose technical qualification status depended upon factory inspection.

8. In accordance with the decision taken by the committee in its last meeting dated 11.02.2019, the factory inspection was conducted by the team of Drug Inspectors deputed for this purpose except the firms those have already been inspected during last one year.

Accordingly, the factory inspection reports and the legal opinion regarding Blacklisting of the firm Aculife Healthcare Pvt. Ltd. by OSMCL and the Honorable Orissa High Court Order no. WP(C) 15723/2018 dated 03.09.2018 that, "there is no legal bar nor the company is blacklisted in view of the order dt. 03.09.2018 passed by the Honorable High Court of Orissa" were placed before the committee in today's meeting. After perusal of which, the drug wise technical evaluation finding in the TEC meeting dated 26.03.19 were recorded as follows:







9. As per the factory inspection reports submitted by the team of Drug inspectors, valid pollution clearance certificate was not available with M/s Shamsree Lifesciences Limited, M/s Haseeb Pharmaceuticals Pvt. Ltd., Pharma Impex Laboratories Pvt. Ltd & M/s Scott Edil Advance Research Laboratories and Education Limited. Hence the TEC recommended to ask for the clarification from the above said bidders and if the satisfactory reply is not received by BMSICL from the concerned bidders within 10 days of issue of this official communication, then the final decision will be taken in accordance with the report submitted by the team of Drug Inspectors.

10. As per the factory inspection report of M/s Haseeb Pharmaceuticals Pvt. Ltd., it has been observed that the license was issued by the concerned licensing authority on 13<sup>th</sup> April 1999 and was valid upto 31<sup>st</sup> December 2017, then the firm has submitted the retention fee in December 2017 but FDA Maharashtra issued a valid certificate from 31.07.2018 to 30.07.2023. Hence there is a gap between 01.01.2018 to 30.07.2018 for a period of seven months. Hence by considering the remarks of the inspection team the TEC in its meeting dated 26.03.2019 recommended to ask for the clarification from the bidder M/s Haseeb Pharmaceuticals Pvt. Ltd. regarding the continuity of the validity of manufacturing license of the firm and if the satisfactory reply is not received by BMSICL from the bidder within 10 days of issue of this official communication, then the final decision will be taken in accordance with the report submitted by the team of Drug Inspectors.




11. Accordingly, clarification was asked from the concerned firms. After comparison of the objection raised by the team of drug inspectors during factory inspection and clarification given by the respective firms, the concerned **bidder wise technical evaluation findings of TEC in its meeting dated 17.05.19** were recorded in Table 1.

After uploading the minutes of the TEC meeting dated 26.03.19 on the website of BMSICL a mail communication was received from Akhilesh Shahu, Executive- Institutional Business, Otsuka Pharmaceutical India Pvt. Ltd. regarding the technical qualification status of M/s. Aculife Healthcare Pvt. Ltd. The **Claim/ Objection disposal status was recorded by TEC in its meeting dated 17.05.19 in Table 2.**

13. The TEC in its meeting dated 17.05.2019 recommended to invite the legal opinion regarding the validity of pollution control clearance certificate for the firm M/s Scott Edil Advance Research Laboratories and Education Limited & M/s Shamsree Lifesciences Limited before taking the final decision in this regard.

Accordingly, the legal opinion has been sought and in accordance with the legal advice, the TEC in its meeting dated 13.06.2019 was unanimously recommended to technically disqualify both the above said firms i.e., M/s Scott Edil Advance Research Laboratories and Education Limited & M/s Shamsree Lifesciences Limited for their all quoted products.

14. The TEC in its meeting dated 17.05.2019 recommended to invite the technical opinion from State Drug Controller regarding the continuity of the Manufacturing License of M/s Haseeb Pharmaceuticals Pvt. Ltd for the period i.e., 01.01.2018 to 30.07.2018 vide letter no. 1094 dated 06.06.2019 before taking the final decision in this regard but the reply from the office of State Drug Controller is still awaited. The onus of continuity of manufacturing license lies with the bidder.



Hence the TEC in its meeting dated 13.06.2019 was unanimously recommended to provide the last opportunity to M/s Haseeb Pharmaceuticals Pvt. Ltd. to justify the continuity of the validity of its manufacturing license for the said period i.e., 01.01.2018 to 30.07.2018 by providing the approval letter issued from their concerned licensing authority only and if the satisfactory reply is not received by BMSICL from the bidder within 7 days of issue of the official communication then the firm will be technically disqualified for all quoted items.

15. Accordingly, a letter has been sent to M/s Haseeb Pharmaceuticals Pvt. Ltd vide letter no.1231 dated 13.06.19 against which the firm has submitted the following clarification through its mail (from mail Id: Haseeb\_p@rediffmail.com) dated 17.06.19:

“As regards to discrepancies in validity period of drug manufacturing license bearing no. ND/44, we have already requested our licensing authority to correct the validity period on our retention license certificate. But being an I.V Fluids unit we are being jointly inspected by CDSCO and our local authority and hence any matter pertaining to our license is also being referred to CDSCO by our local licensing authority. As result, our application for correction in validity period of our license is pending with both the authorities as mentioned above and hence its status is still pending for which any time frame for obtaining the necessary correction cannot be obtained. Under the circumstances we can only request you to proceed as per your time lines and consider our matter accordingly.”

As the firm M/s Haseeb Pharmaceuticals Pvt. Ltd. was unable to justify the continuity of the validity of its manufacturing license for the said period i.e., 01.01.2018 to 30.07.2018 by providing the approval letter issued from their concerned licensing authority, the TEC was unanimously recommended to disqualify the said firm i.e., **M/s Haseeb Pharmaceuticals Pvt. Ltd.**

16. After consideration of all the above facts, the drug wise technical evaluation status in the last TEC meeting dated 20.06.19 were recorded as follows:




