

**MINUTES OF THE FINANCIAL OPENING COMMITTEE MEETING OF RE-TENDER NO.:  
BMSIC/DRUGS/19-02 (RATE CONTRACT AND SUPPLY OF DRUGS FOR DIFFERENT  
HEALTHCARE FACILITIES OF STATE OF BIHAR).**

**Date: 09<sup>th</sup> August 2019**

**Venue: BMSICL Conference Hall.**

The **Financial Opening Committee Meeting of Re-tender No. BMSIC/DRUGS/19-02** was held on 09<sup>th</sup> August 2019 under the Chairmanship of **Managing Director, BMSICL**. The other committee members present in the meeting were:

**2. The Details of the invited tender are as follows:**

1. Tender Reference No. BMSIC/DRUGS/19-02.
2. Tender floated date- 10/01/2019.
3. Last date of submission of Online bids- 03/04/2019.
4. Tender Opening date- 08/04/2019.

3. Tender has been floated for 83 (Eighty-Three) drugs. It was found in online opening that the following 3 (Three) bidders had participated in the tender:

- 1) Ciron Drugs and Pharmaceuticals Pvt Ltd.
- 2) Unicure India Ltd.
- 3) Ornate Labs Pvt Ltd.

**4. The summary of bid received status is as follows:**

1. No Bids received for 66 Drugs.
2. Single Bids received for 14 Drugs.
3. Multiple Bids received for 3 Drugs.

5. It was unanimously decided in Tender Opening Committee meeting dated 08.04.19 to proceed further for technical evaluation for **03 Drugs** (NIT S. No. 2, 73 & 77) for which multiple bids have been received and **14 drugs** (NIT SN- 21, 26, 36, 38, 39, 49, 50, 52, 62, 71, 75, 80, 82 & 83) for which Single bid has been received, as per the Notification of Finance Department, Govt. of Bihar vide Resolution No-7806 Dated-30-09-2016 (this being a retender) and re-tender for the remaining **66 Drugs** (1, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 22, 23, 24, 25, 27, 28, 29, 30, 31, 32, 33, 34, 35, 37, 40, 41, 42, 43, 44, 45, 46, 47, 48, 51, 53, 54, 55, 56, 57, 58, 59, 60, 61, 63, 64, 65, 66, 67, 68, 69, 70, 72, 74, 76, 78, 79 & 81) due to no bid condition.

6. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms were done by the team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections/clarification were invited vide notice no.1049 dated 03.06.2019.

7. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidders, the drug wise technical evaluation findings were recorded by the TEC in its meeting dated 12.06.2019 as follows:

8. The manufacturing units of M/s Ornate Labs Pvt. Ltd. & M/s Unicare India Ltd. have been inspected earlier and BMSICL is having valid rate contract with both the firms. It was unanimously recommended in last TEC meeting to carry out the factory inspection of M/s Ciron Drugs and Pharmaceuticals Pvt. Ltd. whose technical qualification status depended upon factory inspection.

9. After perusal of the Factory Inspection report, the Drug wise technical evaluation findings had been recorded by the TEC in their meeting dated 26<sup>th</sup> July 2019 as follows:

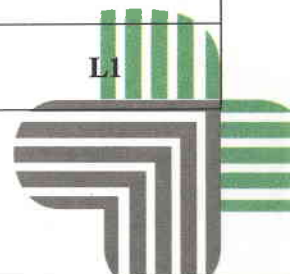

10. Since this Tender is a Re-tender, it was unanimously recommended in its last meeting dated 26.07.2019 to proceed further for opening of financial bids for 01 drug (NIT S1 no. 2) for which multiple bidders have been qualified technically and 13 drugs (NIT S.N.- 21, 26, 36, 38, 39, 49, 50, 52, 62, 71, 75, 82 & 83) for which single bidder has been qualified technically, as per the provisions contained in the Notification Number 7806 Dated 30/09/2016 of Finance Department, Government of Bihar.

11. Accordingly, in today's meeting financial bids of the firms i.e. M/s Ciron Drugs and Pharmaceuticals Pvt. Ltd., M/s Unicure India Ltd. & M/s Ornate Labs Pvt. Ltd. were opened online on E-Proc.

12. After opening of the financial bids (downloaded copies annexed as Annexure I) the rates quoted by all the three technically qualified bidders were found as following and after comparison of which the bid ranking status is recorded as below: -

13. The quoted price for Mefenamic Acid Capsule 500 mg (NIT SI No.38) & Drotaverine Hydrochloride Tablets 40mg (NIT SI No. 75) by M/s Unicare India Ltd. is **0.7499 /-** & **0.4999 /-** respectively. As per financial bid sheet the bidder has to fill the quoted price only upto two digits after decimal. Hence the committee declared M/s Unicare India Ltd. as L1 bidder under single bid condition for the said two drugs i.e., Mefenamic Acid Capsule 500 mg & Drotaverine Hydrochloride Tablets 40mg with unit price of **0.74 /-** & **0.49 /-** respectively.



14. As this tender is a retender, hence it was unanimously decided to ask the bidders to justify their quoted price vis-à-vis other procurement agencies across the country and to find out the prevailing market rate (Authorized dealer price, Carrying & Forwarding Agent Price & Sales depot price) of the corresponding manufacturer through the State Drug Regulatory Authority, so that the matter could be decided by the board of Directors of BMSICL as per the provisions contained in the notification no. 7806 dated 30/09/2016 of Finance Department, Govt. of Bihar.

Accordingly, it was recommended to issue LOI (Letter of Intent) to the above mentioned bidders only after price justification from the bidders as well as State Drug Regulatory Authority & approval from the board of Directors of BMSICL.
