

MINUTES OF FINANCIAL OPENING COMMITTEE MEETING FOR TENDER NO. BMSIC/DRUGS/18-13 (TENDER FOR RATE CONTRACT AND SUPPLY OF VITAMIN A PAEDIATRIC ORAL SOLUTION FOR DIFFERENT HEALTHCARE FACILITIES OF STATE OF BIHAR).

2. The Details of the invited tender are as follows:

3. Tender has been floated for Vitamin A Paediatric Oral Solution. It was found in online opening that total 5 (Five) following bidders had participated in the tender.

4. M/s Unicure India Ltd.
5. M/s Vivek Pharmachem (India) Limited.

4. Preliminary Evaluation of technical bids of the above mentioned 5(Five) bidding firms was done by the team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and clarifications/Objections were invited vide notice no. 4959 dated 16.01.2019.

5. After comparison of the clarifications/objections received in the light of that notice from the bidders and close examination of the documents submitted by the bidding firms a firm wise comparative chart was prepared (as annexed) and on that basis the drug wise technical evaluation findings by the TEC in its meeting dated 23.01.2019 were recorded as follows:-


