M/s Lars Medicare Private Limited, situated at 136, 2nd Floor, Avtar Enclave, Paschim Vihar, Rohtak Road, New Delhi- 110063 was declared as L1 bidder for the below mentioned Medical Devices/Consumables vide tender reference no.- BMSIC/MEDICAL DEVICES/CONSUMABLES/21-12:-

1. IV Set Paediatric and Micro (with unit price of Rs. 9.47/-)

Accordingly, M/s Lars Medicare Private Limited was issued a Letter of Intent (LoI) vide letter no.- 4486, dated 28-09-2022 for submitting the requisite documents, security deposit and to execute the Rate-Contract for the said drug within 10 days from the date of receipt of LoI, i.e by 28-09-2022.

As per Clause 21 1 of the Tender Document, "The supplier shall submit agreement, the hard-copies of the documents submitted and other documents specified, copy of LOI duly signed and sealed on all pages in token of acceptance and the required Security Deposit within 15 days."

The firm, M/s Lars Medicare Private Limited vide mail dated 08-10-2022 informed that "While participating for the tender they were notified that the said product IV set Paediatric and Micro is referred to as Vented IV Set(MICRO) with 14mm Chamber size, Bulb Latex, Luer slip, 150cm tube length and needle, therefore they quoted the rates for the tender considering the explained IV set specification." The firm has quoted the price of IV set Paediatric and Micro in the Financial bid as per the Specification mentioned in the tender documents after technically qualification criteria of BMSICL.

BMSICL issued show cause dated 19-01-2023 but the firm did not reply within the stipulated time frames. The firm has not also submitted the requisite documents for agreement.

Clause 27 A of the Tender Document is relevant for such cases which reads as: "If the Tenderer fails to execute the agreement / to deposit performance security / to perform the obligations under the tender conditions / commits default in the performance of the contract/agreement, such Tenderers will be blacklisted for a period of 2 years by BMSICL from the date of intimation besides forfeiture of EMD/Performance Guarantee. The Tenderers who have withdrawn after participating in the tender either fully or partially, the entire firm/company will be blacklisted for a period of 2 (two) years from the date of intimation by BMSICL apart from forfeiture of the Security Deposit/EMD."
