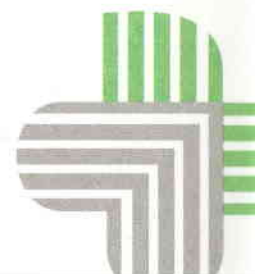

BMSICL had invited bids for the procurement of Reagents vide Tender notice No. BMSIC/REAGENT/18-02. In the online opening, five bids were received. The Preliminary evaluation of these technical bids was done by the team of Drug Inspectors deputed at BMSICL.

The TEC on 30-11-2018 has recommended for constitution of a fact finding committee to deeply enquire into the allegations made by the complainant against the technically qualified bidding firms namely M/s Abbott Healthcare Pvt. Ltd. and M/s POCT Services Pvt. Ltd., so that the matter could be brought to a logical conclusion.

The committee has thoroughly examined the evaluation sheets submitted by the Drug Inspectors during their technical evaluation of this tender. The committee observed that during the technical evaluation all the papers submitted by the bidders have been technically examined, following which the two firms have been declared technically qualified.

However in view of the complain received, the committee feels that the authenticity of the documents submitted by the firms as a part of the technical bid needs to be authenticated on the basis of the verification of the corresponding original documents.



The committee has gone through the minutes of the TEC meeting dated 30-11-2018 and it was also unanimously decided to recommend to intimate the technically qualified firms namely M/s Abbott Healthcare Pvt. Ltd. and M/s POCT Services Pvt. Ltd to be present in front of this committee on 17.12.2018 at 11:00 AM in BMSICL along with all original documents, submitted by the above said firms for the said tender.

The committee has also recommended to intimate the objector/ claimant Mr. Atul Kumar Singh, to attend and substantiate his claim/objections if any with evidence supported by an Affidavit on the above Scheduled meeting i.e 17.12.2018 at 11:00 AM in BMSICL.

The meeting was thus concluded with a vote of thanks.
