The **Technical Evaluation Committee Meeting for Tender No. BMSIC/MEDICAL DEVICES/CONSUMABLES/24-01** was held on **12th June 2024** under the Chairmanship of Dr. Sunil Kumar Jha, Director in Chief, Department of Health, GoB. The other committee members present in the meeting were:

2. The Details of the invited tender are as follows:

2. Tender floated date- 06/03/2024.
3. Last date of submission of online bids- 05/04/2024.

3. The Tender has been floated on e-proc2 Portal for total 03 (Three) Medical Devices/Consumables.

4. A total of 05 (Five) bidders successfully submitted their bids on the e-proc2 online system. The submission status of original hard copy of Earnest Money Deposit (EMD), till the stipulated time was found as following: -

6. The Preliminary Evaluation of technical bids from the aforementioned bidding firms was conducted by the assigned team, including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the BMSICL website, and claims/objections were invited online vide notice no. 665 dated 30/04/2024 on e-proc2.

7. After evaluating the clarifications received from the bidders in response to the notice and closely examining the documents submitted by the firms, the technical evaluation findings by TEC in its meeting dated 28.05.2024 for each firm were as follows:

According to the comparative chart above, a total of Four (04) bidders, namely M/s Caremax Healthcare, M/s Elysia Medical Product Private Limited, M/s Sterimed Surgicals (India) Pvt Ltd & M/s Udaipur Surgicals Pvt Ltd were found technically qualified notwithstanding their product wise qualification status as mentioned above.

9. One (01) firm, i.e., M/s Jajoo Surgicals Private Limited was found technically disqualified.

10. The manufacturing unit of total Three (03) technically qualified firms, namely M/s Elysia Medical Product Private Limited, M/s Sterimed Surgicals (India) Pvt Ltd & M/s Udaipur Surgicals Pvt Ltd were inspected during last three years and/or has valid rate contract with BMSICL.

11. The manufacturing unit of the One (01) firm M/s Caremax Healthcare was not inspected during last three years and did not have valid Rate Contract with BMSICL.

12. The Technical Evaluation Committee in its meeting dated 28.05.2024 recommended to inspect the manufacturing unit of the One (01) firm, M/s Caremax Healthcare.

13. The inspection of the firm was conducted by the team of Drug Inspector deputed at BMSICL and G.M (Procurement), BMSICL. After perusal of the Factory Inspection report, it was found that the firm M/s Caremax Healthcare was technically qualified.

14. It was therefore unanimously decided to recommend for opening of the financial bids of total four (04) Technically qualified bidders on e -proc2 Portal.
