- **8.** According to the comparative chart above, a total of Four (04) bidders, namely M/s Caremax Healthcare, M/s Elysia Medical Product Private Limited, M/s Sterimed Surgicals (India) Pvt Ltd & M/s Udaipur Surgicals Pvt Ltd were found technically qualified not withstanding their product wise qualification status as mentioned above.
- **9.** One (01) firm, i.e., M/s Jajoo Surgicals Private Limited was found technically disqualified.
- **10.** The manufacturing unit of total Three (03) technically qualified firms, namely M/s Elysia Medical Product Private Limited, M/s Sterimed Surgicals (India) Pvt Ltd & M/s Udaipur Surgicals Pvt Ltd were inspected during last three years and/or has valid rate contact with BMSICL.
- 11. The manufacturing unit of the One (01) firm M/s Caremax Healthcare was not inspected during last three years and not has valid Rate Contract with BMSICL.
- 12. It was therefore recommended to inspect the manufacturing unit of the One (01) firm, M/s Caremax Healthcare.
- 13. The meeting thus concluded with a vote of thanks.
