4. The firm M/s Cyano Pharma Pvt. Ltd. has submitted the hard copy of the technical bid document, tender fee & EMD. The firm M/s Grasim Industries Limited has not submitted the hard copy of technical bid document, tender fee & EMD. The firm M/s Adhish Industries has submitted the hard copy of technical bid document & tender fee but not submitted the EMD.

**The Tender clause 6 (b) states that,** “Non-payment of Tender cost and EMD (except in cases where payment of Tender Cost and EMD are specifically exempted) will result in summary rejection of the bid.” Hence, it was unanimously decided to recommend to reject the bids of firms M/s Grasim Industries Limited and M/s Adhish Industries.

2. Single Bids received for **1** Product i.e. Tab. Halazone for solution.
