- 4. It was unanimously decided in Tender Opening meeting dated 14.03.2019 to proceed further for Preliminary Technical Evaluation of all the four bids for 41 Clinical Biochemistry Reagents by the teams of Drug Inspectors deputed at BMSICL.
- 5. The Preliminary Technical Evaluation of the bids of the above-mentioned bidding firms was done by the team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and claims/objections were invited vide notice no.350 dated 26.04.2019.



In contrariety to the minimum eligibility criteria laid down in the clause 3 of he tender document, the import licenses furnished by Kopran have been considered by the corporation for further evaluation. We'd like to apprise you that the conditions laid down in the clause 3 specifically mentions to produce the eligibility document pertaining to the bidder firm only, whereas, a sister concern or a group company having a separate legal entity cannot be considered for evaluation of the bid. In such a case, the bidder company would be acting as a third party agent which is absolutely prohibited aa per the essential terms & conditions for supply of reagents given in the bid document and hence, liable to be rejected on the aforementioned grounds. Apart from the above, clause5- "General Conditions" of the bid document also clearly states that only the direct importers or the manufacturers are eligible to participate in the tender whereas the distributors/agents/loan licenses/contract manufactures are not eligible to participate in the tender. Now only because of your biased reason the health department under scrutiny and patients are suffering but you are interested in only those two companies and you want to handover the whole health system (particularly the diagnosis part) to one particular company out of these two participants. - 8. The TEC in its last meeting dated 14.05.19 was decided to meet again for final decision after the receipt of the legal opinions. Accordingly, the legal opinion has been sought for both the firms i.e., M/s Kopran Laboratories Limited & M/s Abbott Healthcare Pvt. Ltd. The bidder wise crux of the legal opinion is as follows:
 - a) M/s Kopran Laboratories Limited: "It is well settled that the cutoff date to judge the eligibility of a bidder is the date of submission of the bid document. The bidder claims that it had applied before the competent authority for obtaining the import license for remaining three Biochemistry reagents on 25.10.2018, though before the issuance of NIT, but admittedly the firm did not possess valid import license for the said three items on the date of submission of the bid. Even if the firm is granted import license subsequently, that will not cure the deficiency, it had at the time of submission of the bid.

Accordingly, it would not be legally prudent to accept the tender conditionally import license for remaining three items".

- b) M/s Abbott Healthcare Pvt. Ltd.: "It is well settled that the cutoff date to judge the eligibility of a bidder is the date of submission of the bid document. Accordingly, no legal impediment in the decision of the Technical Evaluation Committee in declaring Abbott Health Care as technically qualified subject to the condition that it should produce the Board Resolution along with the Power of Attorney within the aforesaid stipulated period of 45 days, failing which the firm may be rejected from further tender process.
- 9. The Minutes of the TEC meeting dated 14.05.19 was uploaded on the web portal of BMSICL. The claim or objection that has been raised in the name of M/s Transasia Biomedicals Ltd. and its disposal was laid down at page no. 15 and 16 of the minutes of the TEC meeting. Regarding the involvement of M/s Transasia Biomedicals Ltd. as mentioned in the said minutes a letter has been received from the said firm on dated 27.05.19, representing the following points: -
- "(i) We assured you that we have not issued any kind of Letter to BMSICL in recent past. Any Letter issued by Tansasia, used to have our Original Letter Head (white Letter Head with Blue Logo) & Original Signature.
- (ii) Fake Letter received by you on our scanned letter Head is not an Original Letter Head (Scan Copy with black & white Logo) & the signature done by the name is not our employee. We do not have any employee of such name at our Kolkata, Patna or any office across India. Also, the signature is scanned one on the letter received by you.
- (iii) The content of this fake letter is in regard to complain against the Reagent Tender for Semi Auto & Fully Auto Analyzer of BMSICL. We would like to inform you that we had attained the pre bid meeting against this Regent tender at your office. We had raised clarification against certain clauses for amendment for which we had asked by BMSICL to submit the letter through mail. We had submitted the same through mail. We did not participate against this tender as no changes has been done on your amended Tender. When we did not participate against this Tender, then why we will send such type of letter after four months of the tender due date.
- (iv) Further we would like to inform you that Tansasia is the NO. 1 Company in India in IVD Industry. We are associated with all State Govt. & Central Govt. for past 40 Years across the Country. We have a very good track record & having excellent relations with all our Customers. Being a Professional Company, we cannot even think to write such type of letter to a Government & Prestigious Organization like BMSICL with whom we are associated since 2014 & kept our commitment till date.
- (v) It clearly shows that some other company has used our scanned Letter Head & issued this letter to create a bad image of Tansasia in front of BMSICL so that they can free to do all mischiefs & financial frauds when the biggest IVD company of India is out of the contention."
