- 3. The Preliminary Evaluation of technical bids was done by the assigned team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 5902 dated 22.10.2020.
- 4. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the firm wise technical evaluation findings by the TEC in its meeting dated 12.11.2020 were recorded as follows:

^{5.} As per the above comparative chart Six bidders namely, M/s Nandani Marketings Private Limited, M/s HLL Lifecare Limited, M/s Sekhani Industries Private Limited, M/s Shree Radhe Hygiene Products Private Limited, M/s Susheel Yarns Private Limited & M/s Vaidya V & I Infrastructure Pvt. Ltd. were found technically qualified. Hence it was unanimously recommended by the TEC in its meeting dated 12.11.2020 to carry out the physical verification of manufacturing unit of all the above mentioned technically qualified firms.

6. Accordingly, the teams of Drug Inspectors deputed in BMSICL were sent for physical verification of manufacturing units of the above mentioned technically qualified firms. The physical verification teams have recommended to consider these manufacturing units for further tender process. Hence, the Technical Specification Committee meeting for verification of samples of Sanitary Napkin was held today in presence of the representatives of the participating firms.
