

**MINUTES OF TECHNICAL EVALUATION COMMITTEE MEETING FOR TENDER NO.-

KITS USED UNDER NATIONAL VIRAL HEPATITIS CONTROL PROGRAMME FOR DIFFERENT  
HEALTHCARE FACILITIES OF STATE OF BIHAR).**

The **Technical Evaluation Committee Meeting for Tender No. BMSIC/DRUGS/21-08** was held on **22<sup>nd</sup> October 2021** under the Chairmanship of Dr. Navin Chandra Prasad, Director in Chief, Department of Health, GoB. The other committee members present in the meeting were:

**2. The Details of the invited tender are as follows:**

1. Tender Reference No. BMSIC/DRUGS/21-08.
2. Tender floated date- 20/07/2021.
3. Last date of submission of Online bids- 09/09/2021.

**3. The Tender has been floated on e-proc Portal for 09 (Nine) items.**

**4.** Total 05 bidders were found to have successfully submitted their bids on the e-proc online system. The submission status of hard copy of the technical bids including the tender fee and Earnest Money Deposit (EMD), till the stipulated time was found as following: -

**5.** The firm M/s Transasia Bio-Medicals Ltd. neither submitted the Earnest Money Deposit (EMD) & Tender Fee nor considered by the online e-proc system. Accordingly, it was unanimously decided by the TEC in its meeting dated 10-09-2021 to recommend for considering only those above mentioned 05 bidders (Sl. No. 01 to 05) who have successfully submitted their bids online as well as EMD & Tender fee, for further technical evaluation process.

**7. The summary of Bid received status was found as follows:**

1. No Bids received for **02** items.
2. Single Bids received for **05** items.
3. Multiple Bids received for **02** items.

**8.** It was therefore unanimously decided by the TEC in its meeting dated 10-09-2021 to recommend for Re-tender of items at NIT SN- 7 & 9 (**02** items) due to no bid condition and NIT SN- 1, 2, 5, 6 & 8 (**05** items) due to Single bid condition and to evaluate the bids for **those 02 items** (NIT SN- 3 & 4) for which multiple bid has been received.

**9.** The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 5341 dated 11.10.2021.

**10.** After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the firm wise technical evaluation findings in today's meeting were recorded as follows:

**11.** As per the above comparative chart 03 (Three) bidders namely M/s Avantor Performance Materials India Limited, M/s Medsource Ozone Biomedicals Pvt. Ltd. & M/s Tulip Diagnostics Pvt. Ltd were found technically qualified notwithstanding their product wise qualification status as mentioned above. It was therefore unanimously decided to recommend for opening of the financial bids of the technically qualified bidders on e -proc Portal. It was also unanimously decided to Re-tender for the product at NIT Sl.N. 4 (HBsAg (Rapid Test)- whole blood) due to single bid condition.
