7. The summary of Bid received status was as follows:

3. Multiple Bids received for **15** items.

8. It was therefore unanimously decided by the TEC in its meeting dated 19.01.2022 to recommend for Re-tender of Drugs at NIT SN- 2, 4, 6, 7, 8, 13, 15, 17, 20, 21, 27, 30, 33, 34, 36, 38, 43, 44, & 47 (**19 Drugs**) due to no bid condition and NIT SN- 1, 9, 10, 18, 19, 22, 23, 25, 31, 32, 37, 39, 41, 42, 45 & 46 (**16 Drugs**) due to Single bid condition and to evaluate the bids for **those 15 Drugs** (NIT SN- 3, 5, 11, 12, 14, 16, 24, 26, 28, 29, 35, 40, 48, 49, & 50) for which multiple bid has been received.

9. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 9071 dated 23.02.2022.

10. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings in today's meeting were recorded as follows:

As per the above comparative chart total 20 (Twenty) bidders namely M/s Zen Pharma Private Limited, M/s Unicare India Limited, M/s Ultra Drugs Private Limited, M/s Healer's Lab, M/s ANG Life Sciences India Ltd, M/s Bharat Serums and Vaccines Limited, M/s Ciron Drugs & Pharmaceuticals Pvt Ltd, M/s Globela Pharma Pvt Ltd, M/s Health Biotech Limited, M/s La-Chemico Pvt. Ltd., M/s Macleods Pharmaceuticals Limited, M/s Alpa Laboratories Limited, M/s Mascot Health Series Pvt. Ltd., M/s Navkar Lifesciences, M/s Omega Pharma, M/s Ornate Labs Pvt Ltd, M/s Samarth Life Sciences Pvt. Ltd., M/s Preet Remedies Ltd., M/s Pushkar Pharma & M/s Ridley Life Science Pvt Ltd were found technically qualified notwithstanding their product wise qualification status as mentioned above.

The manufacturing unit of the Nineteen (19) firms namely, M/s Zen Pharma Private Limited, M/s Unicare India Limited, M/s Ultra Drugs Private Limited, M/s Healer's Lab, M/s ANG Life Sciences India Ltd, M/s Bharat Serums and Vaccines Limited, M/s Ciron Drugs & Pharmaceuticals Pvt Ltd, M/s Globela Pharma Pvt Ltd, M/s Health Biotech Limited, M/s La-Chemico Pvt. Ltd., M/s Macleods Pharmaceuticals Limited, M/s Alpa Laboratories Limited, M/s Mascot Health Series Pvt. Ltd., M/s Navkar Lifesciences, M/s Omega Pharma, M/s Ornate Labs Pvt Ltd, M/s Samarth Life Sciences Pvt. Ltd., M/s Pushkar Pharma & M/s Ridley Life Science Pvt Ltd. were inspected previously and is having valid rate contract with BMSICL or successfully executed rate contract with BMSICL. The factory inspection of manufacturing unit of the remaining one firm namely M/s Preet Remedies Ltd. was already recommended in Tender no. BMSIC/DRUGS/21-12. It was therefore unanimously decided to recommend for opening of the financial bids of the technically qualified bidders on e - proc Portal after factory inspection.
