It was therefore unanimously decided by the TEC in its meeting dated 19.01.2022 to recommend for Re-tender of Drugs at NIT SN- 3, 5, 9, 10, 11, 14, 15, 16, 17, 18, 19, 31, 32, 35, 42, 43, 44, 45, 47, 48, 50, 51, 52, 53, 54, 55, 56, 57 & 58 (**29** Drugs) due to no bid condition and NIT SN- 1, 2, 4, 7, 8, 12, 13, 20, 21, 22, 23, 24, 25, 27, 28, 29, 30, 33, 36, 38, 40, 41, 46 & 49 (**24** Drugs) due to Single bid condition and to evaluate the bids for **those 05 Drugs** (NIT SN- 6, 26, 34, 37 & 39) for which multiple bid has been received.

8. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 8313 dated 01.02.2022.

9. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the firm wise technical evaluation findings in today's meeting were recorded as follows:
