Ltd neither submitted the Earnest Money Deposit (EMD) & Tender Fee nor considered by the online e-proc system. Accordingly, it was unanimously decided by TEC in its meeting dated 13.04.2022 to recommend for considering only those above mentioned 14 bidders (Sl.
