

**MINUTES OF TECHNICAL EVALUATION COMMITTEE MEETING FOR TENDER NO.-
BMSIC/DRUGS/22-04 (SHORT TENDER FOR RATE CONTRACT AND SUPPLY OF DRUGS
FOR DIFFERENT HEALTHCARE FACILITIES OF STATE OF BIHAR).**

The **Technical Evaluation Committee Meeting for Tender No. BMSIC/DRUGS/22-04** was held on **26th April 2022** under the Chairmanship of Dr. Maheshwar Prasad Gupta, Director in Chief, Department of Health, GoB. The other committee members present in the meeting were:

3. The Tender has been floated on e-proc Portal for 02 (Two) Drugs.

4. Total 18 bidders were found to have successfully submitted their bids on the e-proc online system. The submission status of hard copy of the technical bids including the tender fee and Earnest Money Deposit (EMD), till the stipulated time was found as following: -

5. The firms M/s Bharat Parenterals Limited & M/s Sunford Laboratories LLP neither submitted the Earnest Money Deposit (EMD) & Tender Fee nor considered by the online e-proc system. The firm M/s Vellinton Healthcare has not applied on online E-Proc and only submitted the hardcopy. It was therefore unanimously decided by TEC in its meeting dated 05.04.2022 to return the hardcopy of M/s Vellinton Healthcare. Accordingly, it was unanimously decided by TEC to recommend for considering only those above mentioned 18 bidders (Sl. No. 01 to 18) who have successfully submitted their bids online as well as EMD & Tender fee, for further technical evaluation process.

7. It was therefore unanimously decided by TEC in its meeting dated 05.04.2022 to recommend for technical evaluation of all received 18 (Eighteen) bids by the team of Drug Inspectors deputed at BMSICL.

8. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 412 dated 19.04.2022.

9. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings in today's meeting were recorded as follows:

As per the above comparative chart total 17 (seventeen) bidders namely M/s ANG Life Sciences India Ltd, M/s Arion Healthcare, M/s Concept Pharmaceuticals Ltd, M/s Fantasy Drugs Private Limited, M/s Health Biotech Limited, M/s Pharma Impex Laboratories Pvt. Ltd., M/s Macleods Pharmaceuticals Limited, M/s Alpa Laboratories Limited, M/s Nestor Pharmaceuticals Limited, M/s Marc Laboratories Limited, M/s Protech Telelinks, M/s Sai Parenterals Pvt Ltd, M/s Shamshree Lifesciences Limited, M/s Supermax Drugs And Pharmaceuticals Pvt Ltd, M/s Vivek Pharmachem (India) Limited, M/s Yeluri Formulations Pvt Ltd & M/s Zee Laboratories Ltd were found technically qualified as mentioned above. The manufacturing unit of the Fourteen (14) firms namely M/s ANG Life Sciences India Ltd, M/s Arion Healthcare, M/s Concept Pharmaceuticals Ltd, M/s Health Biotech Limited, M/s Pharma Impex Laboratories Pvt. Ltd., M/s Macleods Pharmaceuticals Limited, M/s Alpa Laboratories Limited, M/s Nestor Pharmaceuticals Limited, M/s Marc Laboratories Limited, M/s Sai Parenterals Pvt Ltd, M/s Shamshree Lifesciences Limited, M/s Supermax Drugs And Pharmaceuticals Pvt Ltd, M/s Vivek Pharmachem (India) Limited & M/s Yeluri Formulations Pvt Ltd were inspected previously and is having valid rate contract with BMSICL or successfully executed rate contract with BMSICL. Since these Drugs have been identified as the crucial drugs for the management of AES according to SOP-2021 and in view of increase in reported cases of AES these drugs are urgently required, hence it was unanimously decided to recommend for factory inspection of remaining Three (03) firms i.e. M/s Fantasy Drugs Private Limited, M/s Protech Telelinks & M/s Zee Laboratories Ltd, later on, provided they are declared as L1, L2 or L3 as per Clause 15 (a) of the bid document which reads as “**Inspections of the production and related facilities of bidders/ suppliers will be at the discretion of the Tender Inviting Authority. Such inspection may be at any stage before or after acceptance of the Bid or Award of Contract**”. It was therefore unanimously decided to recommend for opening of the financial bids of the technically qualified bidders on e -proc Portal.
