7. The summary of Bid received status is as follows:

- 1. No Bids received for **10** items.
- 2. Single Bids received for **03** items.
- 3. Multiple Bids received for **06** items.
- **8**. It was therefore unanimously decided by TEC in its meeting dated 06.04.2022 to recommend for Retender of Drugs at NIT SN- 3, 4, 5, 8, 9, 10, 11, 17, 18 & 19 (**10** Drugs) due to no bid condition and NIT SN- 6, 14 & 16 (**03** Drugs) due to Single bid condition. For the Drug at NIT SN- 13 (Ampicillin 500mg Injection Vial) Rate contract is already existed vide Tender No. BMSIC/DRUGS/19-12, hence it was unanimously decided by TEC in its meeting dated 06.04.2022 to recommend for evaluate the bids for **those 05 Drugs** (NIT SN- 1, 2, 7, 12 & 15) for which multiple bid has been received.
- **9**. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 413 dated 19.04.2022.
- **10**. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings in today's meeting were recorded as follows:

As per the above comparative chart all the bidders namely M/s Ciron Drugs & Pharmaceuticals Pvt Ltd, M/s Protech Telelinks, M/s Pushkar Pharma & M/s Vivek Pharmachem (India) Limited were found technically qualified as mentioned above. The manufacturing unit of the Three (03) firms namely M/s Ciron Drugs & Pharmaceuticals Pvt Ltd, M/s Pushkar Pharma & M/s Vivek Pharmachem (India) Limited were inspected previously and is having valid rate contact with BMSICL or successfully executed rate contact with BMSICL. Since these Drugs have been identified as the crucial drugs for the management of AES according to SOP-2021 and in view of increase in reported cases of AES these drugs are urgently required, hence it was unanimously decided to recommend for factory inspection of remaining One (01) firm i.e. M/s Protech Telelinks, later on, provided it is declared as L1, L2 or L3 as per Clause 15 (a) of the bid document which reads as "Inspections of the production and related facilities of bidders/ suppliers will be at the discretion of the Tender Inviting Authority. Such inspection may be at any stage before or after acceptance of the Bid or Award of Contract". It was therefore unanimously decided to recommend for opening of the financial bids of the technically qualified bidders on e -proc Portal.
