

**MINUTES OF TECHNICAL EVALUATION COMMITTEE MEETING FOR TENDER NO.-  
BMSIC/DRUGS/22-07 (TENDER FOR RATE CONTRACT AND SUPPLY OF DRUGS FOR  
DIFFERENT HEALTHCARE FACILITIES OF STATE OF BIHAR).**

**Date: 17<sup>th</sup> August 2022**

The **Technical Evaluation Committee Meeting for Tender No. BMSIC/DRUGS/22-07** was held on **17<sup>th</sup> August 2022** under the Chairmanship of Dr. Maheshwar Prasad Gupta, Director in Chief, Department of Health, GoB. The other committee members present in the meeting were:

**2. The Details of the invited tender are as follows:**

2. Tender floated date- 23/05/2022.
3. Last date of submission of Online bids- 14/07/2022.

**3. The Tender has been floated on e-proc Portal for 11 (Eleven) Drugs.**

**4.** Total 09 bidders were found to have successfully submitted their bids on the e-proc online system. The submission status of hard copy of the technical bids including the tender fee and Earnest Money Deposit (EMD), till the stipulated time was found as following: -

5. The bid submission of the firms i.e. M/s Cipla Limited, M/s Verve Human Care Laboratories & M/s Unicare India Limited were not considered by the online e-proc system and the said firms only submitted the hardcopy. It was therefore unanimously decided to return the hardcopy of these 03 firms. The firms M/s Sain Medicaments Private Limited & M/s Maan Pharmaceuticals Ltd. neither submitted the Earnest Money Deposit (EMD) & Tender Fee nor considered by the online e-proc system. Accordingly, it was unanimously decided by the TEC in its meeting dated 15.07.2022 to recommend for considering only those above mentioned 09 bidders (Sl. No. 01 to 09) who have successfully submitted their bids online as well as EMD & Tender fee, for further technical evaluation process.

**7. The summary of Bid received status was found as follows:**

1. Single Bid received for **02** Drugs.
2. Multiple Bids received for **09** Drugs.

8. It was therefore unanimously decided by the TEC in its meeting dated 15.07.2022 to recommend for Re-tender of Drugs at NIT SN- 5 & 6 (**02 Drugs**) due to Single bid condition and to evaluate the bids for **those 09 Drugs** (NIT SN- 1, 2, 3, 4, 7, 8, 9, 10 & 11) for which multiple bids have been received.

9. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 3109 dated 08.08.2022.

10. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings in today's meeting were recorded as follows:

11. As per the above comparative chart Seven (07) bidders namely, M/s Bharat Parenterals Limited, M/s Centurion Laboratories Pvt. Ltd., M/s Macleods Pharmaceuticals Limited, M/s Micron Pharmaceuticals, M/s Mylan Laboratories Limited, M/s Aurobindo Pharma Limited & M/s J Duncan Healthcare Pvt Ltd. were found technically qualified notwithstanding their product wise qualification status as mentioned above.

12. The manufacturing unit of the Four (04) firms namely M/s Bharat Parenterals Limited, M/s Centurion Laboratories Pvt. Ltd, M/s Macleods Pharmaceuticals Limited & M/s Mylan Laboratories Limited were inspected previously and these firms are having valid rate contract with BMSICL.

13. As per Clause 15 (a) of the bid document “*Inspections of the production and related facilities of bidders/ suppliers may be carried out at any stage before or after acceptance of the Bid or Award of Contract*”. Since there is an urgent requirement of the tendered drugs in view of AIDS Control Programme, hence, it was unanimously recommended to carry out the physical verification of the remaining firm later on provided they are declared as L1, L2 or L3. It was therefore unanimously decided to recommend for opening of the financial bids of the technically qualified bidders on e-proc portal.
