**8.** It was therefore unanimously decided by the TEC in its meeting dated 06.07.2022 to recommend for Re-tender of Drugs at NIT SN- 2, 3, 4, 5, 6, 7, 8, 10, 11,12, 13, 15, 16, 17, 21, 22, 23, 24, 25, 31, 32, 34, 35, 36, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 53, 54, 55, 56, 57, 58, 59, 60, 61, 62, 63, 64, 65, 66, 67, 68, 69, 70, 71 & 72 (**58 Drugs**) due to no bid condition and to evaluate the bids pertaining to only **those 11 drugs** (NIT SN- 1, 9, 26, 29, 33, 52, 73, 74, 75, 76 & 77) for which Single bids have been received as per the Notification of Finance Department, Govt. of Bihar vide Resolution No-7806 Dated-30-09-2016 (this being a retender) and **08 drugs** (NIT SN- 14, 18, 19, 20, 27, 28, 30 & 51) for which multiple bids have been received.

**9.** The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 3080 dated 05.08.2022.

10. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings in today's meeting were recorded as follows:

11. As per the above comparative chart Ten (10) bidders namely M/s Health Biotech Limited, M/s Ichor Biologics Pvt Ltd, M/s Intas Pharmaceuticals Limited, M/s Nanz Med Science Pharma (P) Ltd., M/s Orison

Pharma International, M/s Ornate Labs Pvt Ltd, M/s Ridley Life Science Pvt Ltd, M/s Unicare India Limited, M/s Reliance Life Sciences Pvt. Ltd., M/s Med Manor Organics Pvt. Ltd. were found technically qualified notwithstanding their product wise qualification status as mentioned above.

12. The manufacturing unit of the Eight (08) firms M/s Health Biotech Limited, M/s Intas Pharmaceuticals Limited, M/s Nanz Med Science Pharma (P) Ltd., M/s Orison Pharma International, M/s Ornate Labs Pvt Ltd, M/s Ridley Life Science Pvt Ltd, M/s Unicare India Limited, M/s Reliance Life Sciences Pvt. Ltd were inspected previously and is having valid rate contract with BMSICL . As per Clause 15 (a) of the bid document ***“Inspections of the production and related facilities of bidders/ suppliers may be carried out at any stage before or after acceptance of the Bid or Award of Contract”***. Since there is an urgent requirement of the tendered drugs, hence, it was unanimously recommended to carry out the physical verification of the remaining firm later on. It was therefore unanimously decided to recommend for opening of the financial bids of the technically qualified bidders on e-proc portal.
