

**MINUTES OF TECHNICAL EVALUATION COMMITTEE MEETING FOR TENDER NO.-

The **Technical Evaluation Committee Meeting for Tender No. BMSIC/DRUGS/22-10** was held on **28<sup>th</sup> June 2022** under the Chairmanship of Dr. Maheshwar Prasad Gupta, Director in Chief, Department of Health, GoB. The other committee members present in the meeting were:

**2. The Details of the invited tender are as follows:**

2. Tender floated date- 03/06/2022.
3. Last date of submission of Online bids- 11/06/2022.

**3.** The Tender has been floated on e-proc Portal for 01 (One) Drug i.e. Zinc Sulphate Dispersible tablet 20mg.

**4.** Total 05 bidders were found to have successfully submitted their bids on the e-proc online system. The submission status of hard copy of the technical bids including the tender fee and Earnest Money Deposit (EMD), till the stipulated time was found as following: -

**5.** It was therefore unanimously decided by TEC in its meeting dated 13.06.2022 to recommend for technical evaluation of all received 05 (Five) bids by the team of Drug Inspectors deputed at BMSICL.

**6.** The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 1869 dated 20.06.2022.

**7.** After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings in today's meeting were recorded as follows:

8. As per the above comparative chart 3 (Three) bidders namely M/s Healthy Life Pharma Pvt Ltd., M/s La-Chemico Pvt. Ltd. & M/s Ridley Life Science Pvt Ltd. were found technically qualified as mentioned above. The manufacturing unit of the above mentioned firms were inspected previously and is having valid rate contact with BMSICL or successfully executed rate contact with BMSICL.
