7. The summary of Bid received status is as follows:

8. It was therefore unanimously decided by TEC in its meeting dated 18.07.2023 to recommend for Re-tender of Drugs at NIT S.N.- 4, 9, 10, 21, 32, 37, 38, 40, 52, 53, 55, 61 & 63 (**13 Drugs**) due to no bid condition & NIT S.N.- 3, 7, 11, 25, 26, 31, 42, 43, 45, 49, 50, 51, 60 & 62 (**14 Drugs**) due to Single bid condition and to evaluate the bids for **those 36 Drugs** (NIT S.N.- 1, 2, 5, 6, 8, 12, 13, 14, 15, 16, 17, 18, 19, 20, 22, 23, 24, 27, 28, 29, 30, 33, 34, 35, 36, 39, 41, 44, 46, 47, 48, 54, 56, 57, 58 & 59) for which multiple bids have been received.

9. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 4261 dated 18.08.2023.

10. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings in today's meeting were recorded as follows:
