**7. The summary of Bid received status was found as follows:**

1. Single Bid received for **02** Drugs.
2. Multiple Bids received for **13** Drugs.

8. It was therefore unanimously decided by TEC in its meeting dated 02.02.2023 to recommend for Re-tender of Drugs at NIT SN- 3 & 14 (**02 Drugs**) due to Single bid condition and to evaluate the bids for **those 13 Drugs** (NIT SN- 1, 2, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 & 15) for which multiple bids have been received.

9. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 9431 dated 24.02.2023.

10. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the Drug wise technical evaluation findings by TEC in its meeting dated 06.03.2023 were recorded as follows:

After perusal of the Factory Inspection report, it was found that the firm M/s Agio Pharmaceuticals Limited, M/s Akums Drugs and Pharmaceuticals Limited, M/s Amster Labs, M/s Bennet Pharmaceuticals Ltd, M/s Cipco Pharmaceuticals, M/s Cotec Healthcare Private Limited, M/s East African India Overseas, M/s Virchow Biotech Pvt Ltd., M/s Westerlin Drugs Private Limited & M/s Zim Laboratories Limited were technically qualified. It was therefore unanimously decided to recommend for opening of the financial bids of all the Thirty five (35) technically qualified bidders on e - proc Portal.
