

**MINUTES OF TECHNICAL EVALUATION COMMITTEE MEETING FOR TENDER NO.-  
BMSIC/MEDICAL DEVICES/CONSUMABLES/22-04 (TENDER FOR RATE CONTRACT AND  
SUPPLY OF MEDICAL DEVICES/CONSUMABLES FOR DIFFERENT HEALTHCARE  
FACILITIES OF STATE OF BIHAR).**

The **Technical Evaluation Committee Meeting for Tender No. BMSIC/MEDICAL DEVICES/CONSUMABLES/22-04** was held on **20<sup>th</sup> September 2022** under the Chairmanship of Dr. Usha Kiran Verma, Director in Chief, Department of Health, GoB. The other committee members present in the meeting were:

**2. The Details of the invited tender are as follows:**

1. Tender Reference No. BMSIC/MEDICAL DEVICES/CONSUMABLES/22-04.
2. Tender floated date- 23/06/2022.
3. Last date of submission of Online bids- 02/08/2022.

**3. The Tender has been floated on e-proc Portal for total 13 (Thirteen) Medical Devices/Consumables.**

**4. Total 07 (Seven) bidders were found to have successfully submitted their bids on the e-proc online system. The submission status of hard copy of the technical bids including the tender fee and Earnest Money Deposit (EMD), till the stipulated time was found as following: -**

5. The bid submission of the firms i.e. M/s Angstrom Biotech Pvt Ltd neither submitted the Earnest Money Deposit (EMD) & Tender Fee nor considered by the online e-proc system. Accordingly, it was unanimously decided by TEC in its meeting dated 03.08.2022 to recommend for considering only those above mentioned 07 bidders (Sl. No. 01 to 07) who have successfully submitted their bids online as well as EMD & Tender fee, for further technical evaluation process.

**7. The summary of Bid received status is as follows:**

1. No Bids received for **06** Medical Device/Consumables.
2. Single Bids received for **03** Medical Device/Consumables.
3. Multiple Bids received for **04** Medical Devices/Consumables.

8. It was therefore unanimously decided by TEC in its meeting dated 03.08.2022 to recommend for Re-tender of Medical Devices/ Consumables at NIT S.N.- 1, 3, 5, 6, 8 & 11 (**06** Medical Devices/Consumables) due to no bid condition and NIT S.N.- 2, 7 & 10 due to Single bid condition and to evaluate the bids for **those 04 Medical Devices/Consumables** (NIT S.N.- 4, 9, 12 & 13) for which multiple bids have been received.

9. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 4140 dated 13.09.2022.

10. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the product wise technical evaluation findings in today's meeting were recorded as follows:

11. As per the above comparative chart Six (06) bidders namely, M/s Unilab Chemicals & Pharmaceuticals Pvt. Ltd., M/s Galaxy Medicare Limited, M/s Goldwin Medicare Ltd, M/s Kemecos India Private Limited, M/s Neelkanth Sodaclays Pvt Ltd & M/s Dr Sabharwals Wound Care were found technically qualified not withstanding their product wise qualification status as mentioned above.

12. The manufacturing unit of the Three (03) firms namely M/s Galaxy Medicare Limited & M/s Goldwin Medicare Ltd & M/s Dr Sabharwals Wound Care were inspected previously and these firms are having valid rate contract with BMSICL. It was therefore unanimously decided to recommend for factory inspection of remaining Four (03) firms i.e., M/s Unilab Chemicals & Pharmaceuticals Pvt. Ltd., M/s Kemecos India Private Limited & M/s Neelkanth Sodaclays Pvt Ltd.
