7. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no. 6533 dated 11.11.2022.

8. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the product wise technical evaluation findings in today's meeting were recorded as follows:

The manufacturing unit of the Four (04) firms namely M/s Iscon Surgicals Limited, M/s Saksham Life, M/s Nanz Med Science Pharma (P) Limited & M/s R R Medical Enterprises Private Limited were inspected previously and these firms are having valid rate contract with BMSICL. It was therefore unanimously recommended to carry out the physical verification of the remaining remaining Six (06) firms i.e., M/s Elysia Medical Product Pvt Ltd., M/s Hi-Tech Medics Private Limited, M/s Hindustan Syringes and Medical Devices Limited, M/s Maruti Meditech Private Limited, M/s Elevation Medisolutions LLP & M/s One Touch Medical Products Private Limited.
