

**MINUTES OF TECHNICAL EVALUATION COMMITTEE MEETING FOR
TENDER NO.- BMSIC/MEDICAL DEVICES/CONSUMABLES/23-10 (TENDER FOR RATE
CONTRACT & SUPPLY OF GLUCOMETER, GLUCOSE TEST STRIPS AND AUTO DISABLE

The **Technical Evaluation Committee Meeting for Tender No. BMSIC/MEDICAL DEVICES/CONSUMABLES/23-10** was held on **March 5th, 2024**, under the Chairmanship of Dr. Sunil Kumar Jha, Director in Chief of the Department of Health, GoB. Other committee members present at the meeting were:

2. The Details of the invited tender are as follows:

1. Tender Reference No. BMSIC/MEDICAL DEVICES/CONSUMABLES/23-10.
2. Tender floated date- 20/09/2023.
3. Last date of submission of Online bids- 01/11/2023.

3. The Tender has been floated on e-proc2 Portal for total 03 (Three) Medical Devices/Consumables.

4. A total of 05 (Five) bidders successfully submitted their bids through the e-proc2 online system. The submission status of the hard copy of the Earnest Money Deposit (EMD) by the stipulated time is as follows: -

5. M/s Ascensia Diabetes Care India Private Limited has submitted a hard copy of the Bank Guarantee (EMD). However, the submitted bank guarantee appears to be a color photocopy. Therefore, it was unanimously decided to verify the authenticity of the Bank Guarantee with their respective bank.

6. The received Bank Guarantee was forwarded to SUMITOMO MITSUI BANKING CORPORATION, New Delhi, and the bank confirmed that the Bank Guarantee is genuine and valid in all respects.

7. Accordingly, during its meeting on 09/01/2024, TEC unanimously decided to recommend considering all five mentioned bidders (Sl. No. 01 to 05) who have successfully submitted their bids online as well as the EMD in hard copy.

9. The Preliminary Evaluation of technical bids from the aforementioned bidding firms was conducted by the assigned team, including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the BMSICL website, and claims/objections were invited online vide notice no. 9863 dated 20/02/2024 on e-proc2.

10. After evaluating the clarifications received from the bidders in response to the notice and closely examining the documents submitted by the firms, the technical evaluation findings for each firm were recorded in today's meeting as follows:
