

MINUTES OF TECHNICAL EVALUATION COMMITTEE MEETING AFTER FACTORY INSPECTION OF TENDER NO. BMSIC/DRUGS/19-05 (RATE CONTRACT AND SUPPLY OF DRUGS FOR DIFFERENT HEALTHCARE FACILITIES OF STATE OF BIHAR).

The Technical Evaluation Committee Meeting after factory inspection of Tender No. BMSIC/DRUGS/19-05 was held on 29th August 2019 under the Chairmanship of Dr. R. D. Ranjan, Director in Chief, Department of Health, GoB. The other committee members present in the meeting were:

- 3. Tender has been floated for 6 (Six) drugs. It was found in online opening that following 11 (Eleven) bidders had participated in the tender:

- 4. It was therefore unanimously decided in tender opening meeting dated 25.07.2019 to recommend for technical evaluation of all received 11 bids for all 6 floated Drugs.
- 5. The Preliminary Evaluation of technical bids of the above mentioned bidding firms was done by the team of Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/Objections/Clarification were invited vide notice no. 2492 dated 06.08.2019.







6. After comparison of the clarification received from the bidders in the light of that notice published on website vide notice no. 2492 dated 06.08.2019 and close examination of the documents submitted by the bidding firms, the drug wise technical evaluation findings were recorded by the TEC in its meeting dated 20.08.2019 as follows:
