5. It was scheduled to conduct the Technical Committee meeting for opening of the received online technical bids on 15th November 2019. But some technical issues were observed while decrypting the received online Technical Bids through the e-Proc (BELTRON) web portal and it was not possible to open the received online Technical Bids on 15th November 2019. Hence it was unanimously decided by Technical bid opening Committee meeting dated 15th November 2019 to re-scheduled the Technical committee meeting for opening of the technical bids on 18-11-2019 at 11:30 AM and to intimate e-Proc, Bihar for resolving the issues relating to opening the received online Technical Bids.

6. Accordingly, the Technical Committee meeting for opening of the technical bids through the e-Proc (BELTRON) web portal was conducted on dated 18.11.2019. **The detailed bids received status were as follows:**

7. The firm M/s Zee Laboratories Ltd. had not submitted the hardcopy. The firms M/s Bharat Parenterals Limited, M/s Galpha Laboratories Ltd, M/s Zee Laboratories Ltd., M/s Apple Formulations Private Limited, M/s Orison Pharma International, M/s Saar Biotech, M/s La-Chemico Pvt. Ltd. were auto disqualified by the online e-proc system. **The Tender clause (3) Note no-(iii) states that, “The technical evaluation shall be done only on the basis of documents/papers submitted by the bidder on www.eproc.bihar.gov.in.”** Accordingly, it was unanimously decided to recommend for considering only those 26 bidders (from sl. No.- 1 to 26 of the above-mentioned list) those were successfully submitted their bids online as well as offline, for further technical evaluation process.

8. It had also been observed by the Technical opening Committee in its meeting dated 18.11.2019 that M/s Reliance Life Sciences Pvt. Ltd. had uploaded the soft copy of the Bank Guarantee for EMD and submitted the photo copy of the prepared Bank Guarantee in the submitted bid document. The TEC hence recommended to ask M/s Reliance Life Sciences Pvt. Ltd. for providing the original Bank Guarantee for EMD and if the original Bank Guarantee was not received by BMSICL from the bidder within 7 days of issue of this official communication then the firm will be technically disqualified.

9. It was also unanimously decided by the Technical opening Committee in its meeting dated 18.11.2019 to recommend to return the hardcopies of received bids for these 6 firms i.e., M/s Bharat Parenterals Limited, M/s Galpha Laboratories Ltd., M/s Apple Formulations Private Limited, M/s Orison Pharma International, M/s Saar Biotech and M/s La-Chemico Pvt. 11. It was therefore unanimously decided by the Technical opening Committee in its meeting dated 18.11.2019 to recommend for technical evaluation for **12 Drugs** (NIT S. No. 1, 2, 3, 6, 7, 8, 9, 10, 15, 16, 17 & 18) for which multiple bids have been received and re-tender for the remaining **8 Drugs** (NIT S. No. 4, 5, 11, 12, 13, 14, 19 & 20) due to single bid & no bid condition.

12. The Preliminary Evaluation of technical bids of the above-mentioned bidding firms was done by the assigned team including Drug Inspectors deputed at BMSICL. Evaluation sheets were published on the website of BMSICL and Claims/objections were invited vide notice no.6240 dated 15.01.2020.

13. After comparison of the clarification received from the bidders in the light of that notice and close examination of the documents submitted by the bidding firms, the drug wise technical evaluation findings by the TEC in its meeting dated 12.02.2020 were recorded as follows:

14. The manufacturing units of Ridley Life Sciences Pvt. Ltd., Salud Care Pvt. Ltd., Shine Pharmaceuticals Limited, Unicare India Limited, Reliance Life Sciences Pvt. Ltd., Wings Biotech, Cyano Pharma Pvt. Ltd., Health Biotech Limited, Healthy Life Pharma Pvt. Ltd., Alpa Laboratories Limited, Nanz Med Science Pharma (P) Ltd., Navkar Lifesciences, Ornate Labs Pvt. Ltd. & Revat Laboratories Private Limited are either inspected within a year or having valid rate contract with BMSICL. It was unanimously recommended in the TEC meeting dated 12.02.2020 to carry out the physical verification of manufacturing unit of the remaining firms i.e., Zenith Drugs Pvt. In today's meeting the members were apprised of the document received from different firms i.e., Current GMP/ WHO GMP Certificate of the firm M/s Medicef Pharma, Maximum Production capacity certificate of the firm M/s Macleods Pharmaceuticals Ltd. & Product approval for three years for the product at NIT Sl No. 7. of the firm M/s Morepen Laboratories Limited whose technical qualification status depended on the said document respectively.
