

Minutes of Technical Evaluation Committee Meeting for Evaluation of Demonstration Sheet for Tender No. BMSICL/2022-23/ME-285 held on 20th March 2023 at Conference Hall of BMSICL Patna,

2. In the TEC Meeting held on 01/02/2023, it was decided unanimously recommended for demonstration of quoted model of equipment by the following technically qualified bidders: -

For the **Ultrasound Machine (Portable)** the technically qualified firms namely M/s Konica Minolta Healthcare India Pvt Ltd., M/s Balajee Enterprises and M/s Hemant Surgicals Industries Ltd demonstrated their quoted model of equipment in presence of committee consisting of experts from NMCH Patna, IGIMS Patna & BMSICL Patna.

For the **Ultrasound Machine with Color Doppler** the technically qualified firms namely M/s Konica Minolta Healthcare India Pvt Ltd., M/s Balajee Enterprises and M/s Hemant Surgicals Industries Ltd **and** M/s Vikash Medical Devices demonstrated their quoted model of equipment in presence of committee consisting of experts from NMCH Patna, IGIMS Patna & BMSICL Patna.

Again demonstration was conducted on 22/02/2023, in which the firm **M/s Vikash Medical Devices** demonstrated their quoted model of Ultrasound Machine (Portable) and the firm **M/s Anupam Surgicals** not demonstrated their quoted model of Ultrasound Machine (Portable). The firm M/s Anupam Surgicals intimated to BMSICL through email to provide more time for the demonstration.
